ACTIONS OF THE BOARD: The Board met on November 3, 1980, and took the following actions:

The health certificate which is required for admission to obedience and show-handling classes will now be required to contain a statement from the vet that the dog is up to date on parvo vaccine.

\$100 will be sent to the James A. Baker Institute for Animal Health (Cornell) to support its canine research programs.

The continuation of the "brag box" will be discussed at the next general meeting, since some members dislike the practice and feel that it is inhibiting the spontaneous reporting of wins. (Please come prepared to discuss this on November 17.)

It has been confirmed that the temperature in the club building should remain relatively constant in order to prevent condensation and sagging of the insulation. Therefore the temperature recommendations reported in October are under review. Various alternatives to running the air conditioning all summer (and paying the bill!!!) are also being explored.

SPRING SHOW PLANS: The spring show has been announced for March 20 at the State Fair Grounds in Raleigh.
