BOARD ACTIONS: The Board has met twice since the last newsletter: on June 21 after the picnic, and on August 19. The following actions were taken:

Decided not to reinvest the \$10,000 Money Market Certificate which was coming due in July at the current low MMC rates, but to put it, at least temporarily, in either Repo or Golden Passbook, at the discretion of the treasurer.

Authorized the treasurer to make double payments on the mortgage for August through December, with a further decision at the December meeting.

Authorized a dumpster to be installed at the Club Building, at the rate of \$28.00/month.

Retained the law firm of Newson, Graham, Hedrick, Murray, Bryson & Kennon to advise re a potential law suit against the DKC.

(The Club has received a letter from a lawyer representing Handler Don Simmons, threatening the Club with a suit because of the way the incident involving Don was handled at the spring show. Mr. Hedrick, of the above law firm, has reviewed all pertinent materials and has contacted Don Simmons' lawyer. No suit has actually been filed as of the date when this newsletter is being prepared, and we will keep you posted about any new developments.)
