IMPORTANT WARNING: METHYLXANTHINE POISONING (CHOCOLATE AND CAFFEINE TOXICOSIS)

Some of our DKC members and fellow dog people may not be aware that there are substances in chocolate, cocoa beans, cocoa bean hulls, cola and tea that are harmful and potentially fatal to dogs, as well as other animals.

Some of the initial signs of caffeine toxicosis include vomiting, restlessness and hyperactivity, muscle tremors, cardiac arrythmias and seizures.

Chocolate ingestion in dogs will be indicated by vomiting, diarrhea, diuresis (sometimes reported as urinary incontinence), hyperactivity, occasional depression, cardiac arrhythmias, temperature(elevated), loss of coordination, muscle tremors, seizures and coma, sometimes terminating in death. Abdominal pain, bloody urine, muscle weakness and dehydration also can be evident.

As there is no specific antidote for methylxanthine poisoning, treatment is aimed at: (1) maintenance of basic life support, (2) prevention of absorption, (3) hastening of elimination and (4) providing symptomatic treatment of seizures, respiratory difficulties and potentially life-threatening cardiac arrhythmias.

If less than 2 hours have elapsed since ingestion, vomiting should be initiated unless the animal is markedly stimulated, comatose or has lost the gag reflex. Chocolate in the stomach can melt and form a ball that can be difficult to remove.

To induce vomiting: 30 cc (15 cc=1 tablespoon) of Hydrogen Peroxide can be given to a large dog. This can be repeated just once in a 15 minute time span. Salt: give large dog 2 teaspoons just once—do not repeat. Syrup of Ipecac: 1 to 2 cc per 2.5 lbs and not more than 15 cc total dose. Can be repeated in 20 minutes, if necessary. If Ipecac was administered, be sure and let your vet. know as this interferes with absorption of charcoal

Please be aware that this is not something to be taken lightly. If you suspect or know that your animal has consumed a considerable amount (the small corner of a brownie doesn't count) of chocolate contact your veterinarian immediately. This can be a life-threatening situation.

Thanks to Jan Hansen for supplying me with the above information. This is something that all of us should be aware of and I appreciate Jan's help.

How about this———Finding Fido or other pets could be a cinch with an identification microchip that is injected under the animal's skin, like a vaccination. If the pet is then lost, scanners at animal shelters or veterinary hospitals can pick up the information on the chip and return the animal to it's owner. The cost: \$40.00.

NATIONAL WAR DOG MEMORIAL:

A nonprofit organization has been formed in Fayetteville, N. C., for the purpose of creating a memorial to war dogs. The National War Dogs Memorial Project, Inc. was founded by ex-Vietnam scout-dog handler, Joe White, who never lost a man while on patrol with his dog 'Ebony', nor was even one wounded.

There is a growing interest in a war dog memorial for both Europe and Australia, with the BBC scheduled to mention Ebony in the dog hero series. Our country has used dogs in every war and yet, this is the first project of its kind, and very possibly, the only one in the world. During one battle alone, at Iwo Jima, nearly 100 dogs died in the line of duty and of course, there have been many, many battles.
