PLEASE READ!!!!

It has been brought to our attention that many of our members are not aware that your DKC dues were to have been paid by June 1, 1991. Notices explaining why this action was approved by your Board were printed first in the October 1990 newsletter, with follow-up reminders in the February and May 1991 newsletters. The Board also agreed that a late fee of \$10.00 would be imposed on those members not paying by the deadline. Because of the apparent confusion, the penalty for late payment will be waived until July 1, 1991. If you have not paid by that date (July 1st) your name will not appear on the updated membership list or if you do pay late you will be charged the late fee of \$10.00.

The following is an exact reprint of the original explanatory notice that was in the October 1990 newsletter.

"The DKC Board met recently to review the proposed budget and it was agreed that some revisions would have to be made in order for our club to operate compatibly with the fiscal year, as outlined in our revised by-laws. Please read the following carefully, as it is important that you understand.

- A) The DKC dues for January 1991 to June 1, 1991 are:
 - \$ 5.00 for member candidate
 - 10.00 for single regular member
 - 15.00 for regular family (husband and wife)
 - 1.00 for Jr. member

The above dues, in the amounts shown, are due and payable on or before January 1, 1991. Any member not paying their dues on or before January 1, 1991 will be charged a \$10.00 late fee and will run the risk of not being listed on the membership list and will, accordingly, be denied membership priviledges. The above dues will be good for a sixmonth period, in order to get us to June, when our fiscal year begins. This half year dues period will bring us into synch with our new by-laws which set our dues to run with our fiscal year.

- B) On or before June 1, 1991, dues will be due in the following amounts:
 - \$10.00 for member candidate
 - 20.00 for single regular member
 - 30.00 for regular family (husband and wife)
 - 1.00 for Jr. member

Please note that the dues have been raised to the amounts shown above to help us meet our ongoing expenses and to assure that our membership income is high enough to allow us to continue to qualify for non-profit tax status. Any member not paying his or her dues by the June 1st deadline will be charged the same late fee as in A) and the same penalties will exist.

In order to receive proper credit for having paid, your dues must be sent to our membership chairman, Mary Oppermann, 2052 Dove Lane, Clayton, N. C. 27520. It is important that your dues be sent to the proper person. The above is for your information".
