2. The following is offered from Brona Hicks regarding the recent Canine Good Citizenship evaluation held at the Mighty Match.

"In the bitter cold of January 15th six intrepid DKC faithfuls ventured forth to evaluate 38 dogs for the CGC program. \$190 was collected for the Mighty Match to donate to the NCSU Veterinary School. Twenty-five dogs passed, twelve failed and one was a "no-show". Obedience commands and separation-from-theowner were the exercises that caused the most difficulty. New breeds tested were Beagle, Mastiff, Saluki and Rhodesian Ridgeback. Our total is 63 different breeds and many mixtures after 9 tests. We still have never tested a toy breed--'anyone want to be first?

Many thanks to Stella Maunsell, Dee Wallis, Sallie Cooper, Betsy Pethick and Angel, Emilie Beglane, Sally Malek and to Barbara Flock who helped with the set up".

Our club is grateful to Brona too, for her continued efforts in offering this most worthwhile test to the general public as well as to our members.
