Shetland Sheepdog: Dog of the Month



The Sheltie, a member of the herding group, was first registered with the AKC in 1911. He has a long, double coat which looks like that of a rough collie,

but the Sheltie is only allowed to measure between 13 and 16 inches at the shoulder or be disqualified for conformation. The shape of the head, when viewed from top or side, is seen as a long, blunt wedge tapering slightly from ears to nose. Color ranges from black, blue merle, and sable (going from golden through mahogany). The ears are carried three-fourths erect with tips breaking forward. This alert and lively dog is quite versatile and the same dog who does well in the conformation ring, often shines in agility and herding as well.

Background

The Shetland Sheepdog traces back to the Border Collie of Scotland, which was brought to the Shetland Islands and crossed with small, intelligent longhaired breeds and in this way was reduced to a more miniature size. Later crosses were made with collies. Although the resemblance between the two is marked, there are many differences between the two breeds, particularly in temperament and grooming time.

Temperament

The Sheltie is bright, gentle, sensitive and never happier then when

working. He is intensely loyal, affectionate and responsive which makes him an ideal family pet and guardian. He is often reserved with other people, but gets along very well with other animals. Shyness, timidity, and nervousness are considered faults by the AKC.

Because of its popularity, there are many Shelties around. It is very important with this breed, as it is with other popular breeds, to choose a breeder carefully.

AKC Delegate's Report

It was my privilege to attend the March 9th Delegates Meeting as the representative of the Durham Kennel Club. The main order of business was the annual election of the AKC board of directors. This year, there were three openings for the class of 2002, and seven delegates were running for those seats. Three were selected by the nominating committee -- Bernard Schwartz, Dr. Robert D. Smith (incumbent), and Kenneth A. Marden (incumbent), and the other four were all nominees from the floor (Robert L. Kelly, Dr. Asa Mays, John L. Ronald and John A. Studebaker). I cast my vote based upon my personal knowledge of the candidates, careful consideration of their published positions on various issues important to the dog fancy, and on conversations with DKC members who were in support of particular candidates. (Many thanks to those who took the time to tell me which candidates they favored and why -- my job is to represent the DKC, and it's much easier to do that with good input from club members!) On the first ballot I voted for Robert L. Kelly, Kenneth A. Marden, and Bernard Schwartz. There were 340 votes cast and 171 or more were needed to garner a seat on the board. Ken Marden & Bob Smith received 223 and 201 votes, respectively, and so were elected to the AKC board. None of the other five remaining candidates received a majority of the votes, which resulted in a second ballot. No candidate on the second ballot received a majority of the vote, although it was clear that the battle was between Robert Kelly (whom I continued to vote for) and Asa Mays. Before the third ballot, John Studebaker and John Ronald withdrew from the election, so delegates could vote for either Robert Kelly, Asa Mays or Bernard Schwartz. Even with the field narrowed to just three candidates, no single candidate received a majority vote on the third vote, so delegates went to the polls for yet a fourth time. On the fourth ballot, Asa Mays became the third member of the class of 2002.

In other business, the Ashtabula Kennel Club was voted in as an AKC member

club, and several changes to the Rules Applying to Dog Shows were voted on. Chapter 2, Section 18 was amended to eliminate the prohibition on advertising an event prior to AKC approval -- AKC does this anyway, in the Events Calendar, and it seemed silly not to let clubs advertise events as pending AKC approval. Your delegate voted in favor of this rule change, and it was passed. The second change was in Chapter 2, Section 19 which stipulates the AKC publications which must be available at an event. Questions arise at events which are covered in these publications (i.e., the Dealing with Misconduct booklet, Guidelines for Obedience Judges, etc.) And it would be helpful to have them on hand. Your delegate voted in favor of this rule change, and it was also passed. Chapter 4, Section 2 was changed so that a postal certification is no longer required when premium list copies are sent to the AKC -- the certifications were difficult to obtain and no one at AKC ever checked them so it seemed pointless to require clubs to obtain one. Your delegate voted in favor of this rule change and it was passed. The proposed change to Chapter 5, Section 4 generated quite a bit of discussion -- this change would have eliminated the prohibition on alcoholic beverages as prizes. Evidently, this rule was put on the books during Prohibition and had never been changed! Many clubs, particularly those in wine producing areas, wanted to be allowed to offer wine in gourmet baskets as prizes. At first I intended to vote in favor of this amendment, but after further thought your delegate voted against it. It seemed to me that in view of the large number of young people under legal drinking age who participate in dog shows (and often win!) offering alcohol as prizes might not be such a good idea. This amendment was defeated. It was proposed to alter Chapter 11, Section 6 so that changes could be made on the day of a show between the Puppy and Twelve-to-Eighteen Month class. I voted in favor of this change, and it passed. The thinking here was that exhibitors could already change between 6-9 and 9-12, and mistakes in 12-18 were just as common as in the other age-limited classes and they ought to be treated the same way. The last Dog Show Rule change was to Chapter 5, Section 10 -- now clubs can offer multiple-win trophies for First Place

in non-regular classes (such trophies used to be allowed only for regular classes). Your delegate voted in favor of this rule change and it passed by a wide margin.

A report was given on the first sixty days of the Compliance Audit Program in which DNA is used to verify parentage and thus protect the integrity of the stud book. DNA was sampled from close to 300 large commercial breeders and puppy mills and it was found that 13% of the almost 600 litters tested had parentage that did not match their pedigrees. Owners of such litters were either suspended or placed on probation. If anyone is interested in more details about the use of DNA to verify parentage, please see me -- I have lots more facts and figures that space prevents me from reporting here.

Likewise, I have many facts and figures from the Treasurer's Report which was presented at the March meeting. In a nutshell, AKC grossed 47 million dollars in 1997, with a net income of 4.7 million. In other financial news, the AKC property in Durham is on the market again as the contract with the Midland Group expired before they could get some required zoning variances. It is expected that the property will be under contract again in the very near future, and should be sold for a tidy profit. If any member wishes to know more about the treasurer's report or the 1997 registration totals, please feel free to contact me -- for brevity's sake I won't go into more detail here, but the information is available should you want

As is always the case, I was grateful for the chance to attend the Delegate's Meeting as your delegate -- it is an honor to represent the DKC! Please let me hear from you if there is any more information that I can provide or any questions I can answer. My ears are always open!


Say how wonderful it was to have the space, Great environment for obedience, Judges appreciated the facility Hope we will be permitted to use it next year, etc etc etc.
