Yorkshire Terrier: Dog of the Month



The Yorkshire Terrier is a intelligent and robust toy breed. He is lively, lovable and affectionate with his master and fre-

quently suspicious with strangers and is often the attacker against large dogs. He loves the outdoors when it is not too cold and is an excellent watchdog. Yorkies kept for show will have long hair reaching to the ground and will require a great deal of grooming.

Background: The earliest ancestors of the Yorkie were kept by Scottish weavers for ratting. Although this is not an ancient breed, it has changed quite a bit during its history. The first Yorkies were bigger and heavier than today's standard requires. Some of the terriers who were crossbred in the 1800s to produce the Yorkshire Terrier of today include the Waterside, Black and Tan, Paisley and Clydesdale Terriers.

The Yorkshire Terrier was first shown in England in 1861 and was recognized by the Kennel Club of England in 1886. At that time, Yorkies weighed as much as 12 to 15 pounds. Now they must weigh 7 pounds or less. Five pounds is the most desired size.

Show Ring: The Yorkshire Terrier is a long-haired toy breed that must be dark blue with tan head and fore-quarters. The head held high and jaunty, has a short muzzle, flat skull and forward looking eyes with dark rims. The bite should be scissors or level. The back should be level and short, above straight forelegs and

only slightly bent hindlegs. The docked tail is carried higher than the back.

The coat is the Yorkshire's most important feature. Color must be steel blue (not mixed with black or tan) on the body from the neck up to the tip of the tail. A clear tan must show on the head, chest, legs and underside of the tail. The long, tan fall of hair on the head and face should have dark roots, but it should not be mixed with black. The fall may be groomed with one ribbon or parted and held with 2 ribbons. Puppies that become correct steel blue with tan color are always born black with small tan markings.

Breed Disqualifications: Although there are no disqualifications, the most common fault is deviation from color standard.

Recognized Problems: Hypoglycemia occurs, especially in smaller puppies and Patella luxation is a continuing problem in Yorkies.

AKC Delegate's Report -- June & September 1999 Meetings

The June, 1999 Delegates Meeting was held in Raleigh, and the consensus amongst the delegates was that the meeting went very well indeed. The AKC staff had several special events planned for the delegates, including a murder mystery dinner at the North Raleigh Hilton, garden and sightseeing tours, and a tour of the AKC North Carolina Operations Facility. The whole Triangle area was presented in a very positive light, and I heard nothing but good comments from other delegates. I was especially impressed with the tour of AKC's Raleigh offices – the staff were very knowledgeable and friendly, and the volume of mail and the number of phone calls they dealt with on a daily basis was just amazing. While at the Raleigh offices, delegates were given a preview of the new AKC website, and the new registration forms, both of which have been revamped in an effort to make them more user friendly.

At the actual meeting, the Mt. Baker Kennel Club, the Peninsula Dog Fanciers Club, the Southern Oregon Kennel Club, and the Portland Dog Obedience club were all voted in as member clubs. In his report, Chairman David Merriam discussed upcoming changes to the judges approval process, and discussed issues of territoriality. Of major concern is whether or not clubs can hold shows in territories that aren't their own without permission of the host club. In the President's report, Al Cheaure focused his comments on the new registration form, which will hopefully help to increase registrations and reduce the mistakes that are common with the old blue slips. There was only one issue up for a vote – a proposed amendment to Article XVI, Section 2 of the Constitution and Bylaws, which would make it obligatory that each meeting notice mailed to delegates include the most current quarterly financial report, except for the annual meeting, which would be accompanied by the financial report for the fiscal year just ended. There was much discussion on this amendment. The AKC accountants were against it, as they said it was not traditional for not-for-profit organizations to give quarterly reports. The AKC board was also against it, although many delegates spoke in favor of the amendment. In the end, the vote was 151 in favor and 101 against, so the amendment did not pass since a 2/3 majority is required. Your delegate voted in favor of the amendment. Two amendments were read and would be voted on at the September meeting, one which would make changes in many places in the AKC constitution in order to make the language consistent throughout, and one which would allow time for discussion of a proposed rule change at the time it is read to the delegate body, in addition to when it is voted upon.

The September Meeting was held in New York once again, and the Clearwater Kennel Club, the Greater Swiss Mountain Dog Club of America and the Shoreline Dog Fanciers Association were voted in as member clubs. The Delegates Forum focused on discussion of the Constitution and Bylaws committee report, as the changes they recommend to the AKC constitution were to be voted on in the afternoon. The recommendations were:

- to consistently use "AKC" to refer to the organization
- to make the Bylaws gender neutral
- to add the word "purebred" to dog, where applicable
- to use the phrase "Dog Events" and "Event Committee", where applicable.

When these amendments came up for a vote, there was much discussion when a delegate pointed out that these changes would alter Article IV, Section I so that the delegate body would have the power to change rules for all dog events rather than just dog shows and field trials. Many delegates seemed in favor of this change, presumably because it would put more power in the hands of the delegates. Your delegate was strongly opposed to making this change, since the vast majority of the delegate body knows very little about performance events outside their own area of interest, and therefore really aren't qualified to vote on rule changes that could have a sweeping impact on the sport. Fortunately, it was proposed to use "Dog Events" as a generic term everywhere except Article IV, Section I, and after more heated debate, this amendment passed, as did the rest of the "housekeeping" changes to the Constitution and Bylaws. Your delegate voted in favor of the changes, once Article IV, Section I was excluded. The second item up for a vote was a proposed special rule of order which would allow proposed Bylaw and rule changes to be discussed at the time they are read to the delegates, rather than only when they are voted on, as is currently the case. Your delegate voted in favor of this rule of order, and it passed by a large majority.

In other business, elections were held for seats on the Delegate Standing Committees. There are eight committees and over thirty people were elected to serve on them – in the interest of brevity I won't name who was elected to each committee, but any club member who is interested is encouraged to contact me for further information, or see the election results listed in the October Gazette.

The next Delegates Meeting will be December 14th, in New York, and I do plan to attend. The agenda for that meeting is not yet published, but it should be available in time to be published in our next newsletter – as always, please feel free to contact me with any questions or concerns.
