Irish Setter: Dog of the Month

The Irish Setter requires play, exercise, love patience and

and above all, patience and acceptance. It can be a snob or a clown, but is always loyal to its owners. These dogs may be supersensitive or hardheaded, but rarely lack intelligence. They often like to play dumb, and few dogs are as adapt at acting as the Irish Setter.

The Irish Setter was bred for the country and some do not do well as city dogs. A house-bound Irish Setter may act like a "crazy dog" because the owners do not realize how much exercise he needs. If he is properly trained, he will make a wonderful companion. The Irish Setter's combination of intelligence and independence can cause problems if he is not properly controlled.

Background: The Irish Setter first became popular early in the 18th century and less than 100 years later, its reputation was firmly established in its native Ireland and throughout the British Isles. Its origins are guesswork. There is no breed which has a clear title to this honor. Some believe that he was developed from a Irish Water Spaniel–Irish Terrier cross, but most believe that it was an English Setter-Spaniel-Pointer blend with a dash of Gordon thrown in.

Show Ring: The ideal Irish Setter dog is 27 inches at the withers and weighs about 70 pounds; the ideal bitch is 25 inches tall and weighs 60 pounds. The body is slightly longer than tall and the legs should be sturdy with plenty of bone.

Breed Disgualifications: There are no disqualifying breed faults. Breeding and Whelping: Bitches have very erratic estrous cycles. Some bitches regularly come into heat at 6 month cycles and others can go as long as 2 to 3 years between periods. First estrus may not occur in some until they are 3 years old. Mastitis is seldom a problem, but they can become hyperactive after whelping. A litter of 14 is not uncommon. Birth color varies and the adult coat cannot be determined until the puppies lose their baby fuzz and develop a dark streak down their backs. Often, though, the fringes of the ear tips show adult color.

Recognized Problems: Broken bones are common in puppies up to a year and one-half. Growth disturbances have become more common and may be related to over-nutrition. **Hip dysplasia** is estimated at 35 %, but seems to be decreasing.

Old Age: Strokes are common in aged dogs and bloat increases dramatically as the dog grows older. The average life span is 11.1 years.

BOARD APPROVED FUS DNA PROGRAM

At its January 10th meeting, the Board of Directors of the American Kennel Club approved a Frequently Used Sire (FUS) DNA program, prior to registration of the next litter, for those sires with six or more registered litters and those sires producing three or more litters in a calendar year. Effective for litters whelped on or after July 1, 2000, the program requires stud dog owners of these dogs to submit their dog's DNA with the AKC. Owners should get the DNA Test Kit from AKC Fulfillment Department, 5580 Centerview

Drive, Raleigh, NC 27606 and return the dog's cheek swab DNA sample with the accompanying, required paperwork and the payment of a \$40 processing fee to AKC's DNA Operations in Raleigh. The sire's DNA will then become a permanent part of his AKC records.

Any stud dog whose DNA has already been collected through AKC's Voluntary Certification Program or the Parent Club Program does not need to be redone as his DNA is already on file and the requirement will be considered as having been "DNA satisfied. Every Certification" is valid for the lifetime and beyond of the sire.

The discipline policies of the Compliance Audit Program will also be applied to this program. Any litter found to be excluded from 7/1/2000 forward based on DNA testing can either be corrected or, if not corrected, will be cancelled. Owners of stud dogs who signed the litter application attesting as to the sire of the litter may be subject to suspension of all AKC privileges if two or more litter applications are submitted to AKC within a three-year time period certifying the incorrect sire.

Every stud dog that falls in the above parameters must have his "DNA Certification" on file with the AKC prior to the registration of its seventh or higher litter or his fourth or more litter within a calendar year.

Any excess funds accumulated as the result of the FUS program will be set aside and used to fund a future registration integrity programs.

Obituaries (AKC)

James H. Moran - Multi-group judge (Toy and Non-sporting and some Sporting breeds, BIS) and former Pug breeder, Jim Moran died of natural causes while on a judging assignment in Sarasota, Florida on January 11th, 2000. Jim had been president of the American Dog Show Judges Association at the time of his death. He is survived by his wife, Grace, and resided in Oregon.

Sunny Dutton - Longtime breeder and multi-group judge (Sporting, Toy & No-sporting) passed away of natural causes on January 13th, 2000. She was a resident of Illinois.

James Cavallaro - Very active, multi-group judge (Toys, Nonsporting & provisional Working, & BIS) and former Pug breeder died on January 16th, 2000 as the result of a inoperable brain tumor that was discovered just two months ago. Jim lived in Florida and was active in the Greater Daytona Dog Fanciers Association.

Quentin LaHam - Popular lecturer on anatomy and movement, allbreed Canadian judge, multi-group American judge (Sporting, Working, Herding and some Terrier breeds, BIS), was killed on January 17th, 2000 in an automobile accident that occurred in front of the hotel where the judges were staying for the allbreeds shows Brookville. in Florida. He was a resident of California at the time of his death and reportedly was looking for property to relocate to Florida with his wife, Betsy, at the time of the accident.


Betsy LaHam - Former AKC Field Representative and Afghan Hound breeder, multi-group judge (Herding, Working, Shih Tzu & BIS), seriously injured in the automobile accident that killed her husband, Quentin. Betsy died the following morning, January 18th, 2000, while undergoing a second surgery in an attempt to save her life.
