### Pembroke Welch Corgi: Dog of the Month



The **Pembroke Welch Corgi**, the Corgi with the docked tail, is the smallest member of the Herding Group. It originated from the same family that includes the Finnish Spitz, the Keeshond, the Samoyed, the Norwegian Elkhound, the Chow Chow and the Pomeranian. Unlike the Cardigan Welsh Corgi, Pembroke does not have Dachshund characteristics.

Low-set, strong, sturdily built and active, giving an impression of substance and stamina in a small space. The Pembroke Welsh Corgi is an active dog who is willing and able to carry out his owner's commands in the pasture, the obedience ring, or the family home. The typical Pembroke is happy, obedient, friendly, confident and great fun to live with.

**Background:** Although evidence seems to show that the Pembroke is a much younger dog than the Cardigan, it is still true that this is a breed of considerable antiquity. The Pembroke was brought to Wales in AD 1107 by Flemish weavers. The two Corgi types were crossed before the middle of the 19<sup>th</sup> century.

The two Corgi types differ. The Pembroke is shorter in body with straighter, more lightly boned legs. His coat is of a finer texture than that of the Cardigan. The Pembroke ears are pointed at the tip and stand erect; the Cardigan has rounded ears. The Pembroke tail is docked as short as possible without being indented while the Cardigan has a long tail. In disposition, the Pembroke is more restless, more easily excited.

Approval was given to the Pembroke Welch Corgi by the AKC on June 13, 1972 (Reformatted Jan. 28, 1993).

**Show Ring:** Height (from ground to highest point on withers) should be 10 to 12 inches. Weight is in proportion to size, not exceeding 30 pounds for dogs and 28 pounds for bitches. In show condition, the preferred medium-sized dog of correct bone and substance will weigh approximately 27 pounds, with bitches approximately 25 pounds.

The outer coat is to be of self colors in red, sable, fawn, black and tan with or without white markings. White is acceptable on legs, chest, neck (either in part or as a collar), muzzle, underparts and as a narrow blaze on head.

**Breeding and Whelping:** Breeding problems are not infrequent. Litter size is usually 6 to 7, with 10 to 12 pups not being uncommon. Birth weigh is usually 6 to 19 ounces.

**Breed Disqualifications:** There are none. Although, a dog must be very seriously penalized for the following faults, regardless of whatever desirable qualities the dog may present: oversized or undersized; button, rose or drop ears; overshot or undershot bite; fluffies, whitelies, mismarks or bluiies.

**Recognized Problems:** This breed is subject to **cervical disc syndrome** and **epileptic seizures** There is, also, a high risk of **bladder stones and urinary-tract problems**.

**Old Age:** Average life span is **12.5 years**.

## AKC Delegate's Report

I was once again privileged to represent DKC at the Delegate's Meeting on December 12, 2000. The meeting began with the informal delegate's forum, where the Chairman and the President reported that a survey will be sent to all member clubs to receive input on the number of delegate meetings they would like to be held and how many they would like to see held outside New York. They also announced the formation of a DNA advisory committee which will meet at least twice a year for two years and will report to the board after that time. So far, the DNA parentage identification program has been very successful, resulting in over 120,000 dogs in the database, and there has been a 50% improvement in inspections over the past year.

After the forum, the formal meeting was convened and discussion

began on the amendments to the Constitution and Bylaws which pertain to club membership and delegate eligibility. The first article to be addressed was IV-B, which provided a cap on the number of clubs to be admitted to membership, and after much debate, it was defeated. Your delegate voted against setting membership caps in the fashion mandated by article IV-B. Once the first section of that article was defeated, several of the other sections were withdrawn, as their initial proposal was predicated on passage of the first section. In the end, the only part of article IV-B that passed was the amendment that removes the provision for specialty clubs other than parent clubs to become members. This amendment also strengthens the authority of the parent club over the standard, since a local specialty club can no longer appeal a parent club's decision regarding changes in the breed standard. Your delegate voted in favor of those changes. Next, came much discussion over whether to allow judges who charge a fee in excess of actual expenses to become delegates. As predicted, this amendment did not pass, nor did an amendment which would have established minimum requirements for becoming a delegate. Your delegate voted against both of these amendments.

Unfortunately, by this time the meeting had gone on so long that I had to leave in order to catch my flight home – the weather was worsening and I was afraid I wouldn't be able to leave at all if I waited for the next flight! Therefore, I wasn't able to vote on the following amendments, but I can still report on the decisions reached. The proposed amendment to Article VIII, which would have added a new section 8 and would have prohibited members of the nominating committee from running for the board, was

defeated, since it would have been in conflict with Robert's Rules of Order. The change to Chapter 14, Section 10 of the Dog Show Rules was passed, so it will no longer be necessary for clubs to require the return of ribbons in the case of cancellations of placements in the classes. It is important to note that this change applies to ribbons only – prizes must still be returned to the show giving club, so that they might be given to the proper winners. The amendment to Chapter 16, Section 3 of the Dog Show Rules which changes the way points are calculated at independent specialty shows for breeds with varieties was also passed. Changes to Chapter 16, Section 5 which concerns the recognition of dual champions in field trials and herding trials was separated into two parts. The first part, the recognition of dual championship for herding dogs, was passed, but the second part, involving the designation of dual champion for field trial dogs, was postponed to allow delegates to consult with club members with field trial experience. Please note that any members with opinions on this matter should contact me before the March meeting. The final bit of business was a vote on an amendment to Chapter 3, Section 1 of the Beagle Field Trial Rules which eliminates March deadlines and allows clubs to apply for this event during the course of the calendar year, using the corresponding date system.
