Wirehaired Pointing Griffon: DOG OF THE MONTH



The Wirehaired Pointing Griffon, a member of the Sporting Group, is medium sized, and bred to cover

all terrain encountered by the walking hunter with his movement showing an easy catlike gracefulness. It is best if he lives in the country where there is plenty of room for exercise. He excels equally as a pointer in the field, or a retriever in the water. His easy trainability, devotion to family, and friendly temperament endear him to all. The nickname of "supreme gundog" is well earned.

Background: The Wirehaired Pointing Griffon comes from a breeding in 1874 by E.K. Korthel of what is thought to have been an Otterhound, a Setter, possibly a Pointer and some larger Spaniels in an attempt to produce a new sporting breed. The first of these dogs was brought to America in the 1900s. They were first called Russian Setter Griffons.

Approved by the AKC: October 8, 1991; Effective November 28, 1991

Show Ring: Size: 22 to 24 inches for males, 20 to 22 inches for females. Correct size is important. Oversize to be severely penalized. Eyes: large and well open, more rounded than elliptical. Ears: medium size, lying flat and close to the head. Coat: is hard and coarse, never curly or woolly, with a thick undercoat of fine hair, giving an unkempt appearance. Nose: color is always brown. Feet: round, firm, with tightly closed webbed toes. Pads are

thick. *Tail:* carried straight or raised slightly. It is docked by one-third to one-half length. *Color:* preferably steel gray with brown markings, frequently chestnut brown, or roan, white and brown; white and orange are also acceptable. Bite: scissors. Overshot or undershot bite is a *serious fault*.

Breeding and Whelping: There can be problems with the delivery and early care of the puppies. Some of the problems arise from the bitches temperament. No disturbance for the first few days is helpful. **Eclampsia** is seen in this breed. Litters average 4 to 12. In picking a puppy, one should look for a slender head and an undercoat.

Disqualifications: Nose any color other than brown. Black coat.

Recognized Problems: Hip dysplasia. Routine removal of hair inside the ear is suggested to prevent otitis externa.

Old Age: The average life span of the **Wirehaired Pointing Griffon** is 10 to 11 years.

Spring DKC Agility Trials

DKC hosted 3 days of all breed agility trials April 22-24 at the show grounds on Harris Rd. Rougemont. The grounds had been beautifully maintained by Roger Akers and George Beglane and drew compliments from many on how lush and well cared for they Our judge Blair Kelly from were. Maryland provided us with fun yet challenging courses throughout the weekend. The weather ran the gamut from 80 degrees and balmy on Friday afternoon to 42 degrees and blustery winds on Sunday. It only sprinkled a few times so all in all, we were pretty lucky.

This was the first time we used the increased limits of runs now allowed by AKC. Over the 3 days we handled 860 runs all timed, scored,

and tabulated. Our judge took no breaks for himself in spite of our urging him to do so. Friday he was at the show site by 9:30 am. Judging started at noon and ended at 5:00. He was out there Saturday and Sunday by 6:45 am to give out the course designs for the first two courses to be built. Judging began promptly at 8 am and ended judging and all the paperwork by 4 pm. He was extremely efficient and easy to work with, but he did admit his feet hurt!

As usual there were lots of herding and sporting breeds, but also representatives from each of the 7 groups. Many Dobies, Labs, Goldens, one very entertaining Greyhound, dozens of Shelties, several Border Collies and Aussies. poodles and Boston Terriers, Border Terriers, Westie, Scottie, one Toy Fox Terrier who finished her Master Agility Championship on Sunday, Papillons, a Beagle, Corgis, Collies, Belgian Tervuren, Malinois, and Sheepdog, Cavaliers, Dalmatians and more.

Every event chairman knows it takes a large number of people to put on events such as these, not to mention the fact that there were 3 trials! This chairman wants to thank every DKC member who showed up to help and be a part of making the trials a success. There are way too many to name them all, but consider yourself thanked and please know you were greatly appreciated including leash and score runners, bar setters, scribes, timers, and gate stewards. An enormous "thank you" goes to Richard Whorton who once again made being trial secretary look easy. Few know that he probably puts in 40 hours of work for these trials of time ahead preparing premium numbering list. opening the hundreds of envelopes, entering the entry info into the database, e-mailing confirmations, alternate maintaining an answering questions, and printing scribe sheets, gate boards, arm bands, catalogs, and processing move-ups for each of the 3 days, plus scoring all the 860 runs over the 3 days. Thanks to Tracy Fletcher for helping maintain our equipment, replacing old worn out stuff with new, and building 14 courses over the 3 days. George and Emilie Beglane are always there to help in so many ways including hauling the trailer, loading and unloading it as well.

This year there was a new face who helped make the trials a big success. When I found myself two weeks before the trials with no one to serve food for our exhibitors and workers in spite of making numerous phone calls and sending dozens of e-mails. I decided it was time for action. I cornered Roger Akers at an agility trial in early April and asked if he would do the food. reluctant at first, never having done such a task but eventually agreed to do it. Never have we had so many compliments on our food! Roger rose to the occasion and served burgers, hot dogs, chicken breast sandwiches, fruit salads and more. Cheers to you Roger!!!

Membership Dues

It's that time of year again. and Membership Dues Forms with all your DKC data to be checked and updated were sent out to over 230 households.

The data is being updated with the forms that you sent in and a new membership list will be available in September. The membership lists will be made available at the September meeting and online as an Adobe file (PDF) if you request it from me.

From the DKC By-Laws:

Article I. Membership

Section 2.: Membership dues are payable on or before the first day of June of each year. Regular Members joining the Club after January 1 and before June 1 shall pay one half of the annual dues for that year. No Regular Member may vote whose dues are not paid for the current year. The April Newsletter will have a Dues reminder. The May and June Newsletters will contain the Dues Form.

Section 4 b: Lapsing.

A membership will be considered as lapsed and automatically terminated if such member's dues remain unpaid 30 days after the first day of the fiscal year. However, the Board may grant an additional 90 days of grace to such delinquent members in meritorious cases. In no case may a person be entitled to vote at any Club meeting whose dues are unpaid as of the date of that meeting.

Article IV. The Club Year, Annual Meeting, Elections

Section 1. Club Year. The Club's fiscal year shall begin on the 1st day of June of each year and end on the 31st day of May of the next year. The Club's official year shall begin immediately at the conclusion of the election at the annual meeting and shall continue through the election at the next annual meeting.

Please remember Membership Renewals are due June 1st.
