# Borzoi: Dog of the Month

**Hound Group** 



The **Borzoi** (or Russian Wolf-hound before 1936) has been used since the

17<sup>th</sup> century for hunting wolves, coursing hare and other game relying on sight rather than scent. The Borzoi should always possess unmistakable elegance, with flowing lines, graceful in motion or repose. He does need exercise. He is silent, docile, reserved, loyal and may have a stubborn streak. This breed is generally even tempered adjusting well to any situation.

**Background:** The Borzoi was bred by the Russian aristocracy for hundreds of years with vast estates set aside for breeding and training. The first Borzoi standard was written in 1650 and did not differ greatly from the standard of today.

AKC Approved: June 13, 1972.

Show Ring: A unique feature of the breed is its slightly convex topline. Size: Mature males should be at least 28" at the withers and mature bitches at least 26". Dogs and bitches above the respective limits should not be penalized as long as extra size is not acquired at the expense of symmetry, speed and staying quality. Weight range for males is from 75 to 105 pounds and for bitches, 15 to 20 pounds less. Eyes: Dark in color, intelligent but rather soft in expression; never round. Ears: Small and fine in quality, lying back on the neck when in repose. Bite: Even or scissors. Coat: Long, silky (not woolly), either flat, wavy or rather curly. Feet: Hareshaped, with well-arched knuckles, toes close and well padded. Tail: Long, set on and carried low in a

graceful curve. *Color:* Any color, or combination of colors, is acceptable.

Breeding and Whelping: Bitches should not be bred before they are 2 years old. Breeding must be supervised to avoid injury to one or both. The bitches long thigh and tail hair needs to be clipped before whelping to avoid puppy strangulation. Whelping is usually without problems, but some bitches have difficulty delivering the last pup. Pups generally weigh about a pound.

Dewclaws, if any, on the hind legs are generally removed; dewclaws on the forelegs may be removed.

**Serious Faults:** Dogs below 28" and bitches below 26".

**Other Faults:** Missing teeth. Any deviation from the standard.

**Disqualifications**: None.

Recognized Problems: Gastric bloat and torsion. Sensitive to cholinesterase inhibitors [as in flea collars] and their response to all barbiturates is unpredictable.

**Old Age:** If a Borzoi passes the age of 4-6 years, a life span of 12-15 years is not uncommon.

We have a new item, Loan Principal, which is for our new land purchase. We also changed from SunTrust to First Citizens Bank.

AKC Delegate: The last meeting was held March 13 & 14 in New York. Dog show entries are about the same. The major factor in conformation is the Judges panel. The performance entries are down. AKC hoped that Rally would increase Obedience entries. It does not look like this is happening. AKC will collect some statistics on this.

Dog Show Rules – Statistics are being looked at to see if the Limited Registration dogs are entering shows. These have been caught after the show and have caused a problem regarding the points awarded at these shows. AKC is looking at either putting an L after the Registration number or eliminating Limited Registration.

The Championship Point Schedule is also being looked at for a new revamping. AKC is looking at dividing the areas differently and making them larger.

There is a new discussion on PAWS which Linda sent via the DKC e-mail system to the membership.

AKC finances are the strongest in the history of AKC.

There are many new things available to member clubs such as a syndicated column on the AKC web site.

This was the meeting which included the Annual Election of Directors and two new people were elected.

The AKC Seal was revised which now included the AKC founding date.

Items discussed that will be up for a vote at the June meeting include: a change in the nomination procedure and allowing professional Judges to become Delegates.

New Business: Letter to President – There are four questions about the nominations and I will answer them.

- 1) How does the Slate come about? The DKC Board appoints an Election Committee Chair who selects a committee of five. The Committee comes up with the slate of at least one person per position by first asking in writing if the current Board members want to continue in their current position and if not, if they would accept a nomination for another position on the Board or step down from the Board. The Committee get all of the nominees consent to be on the slate in writing and report the slate to the Recording Secretary.
- 2) Does the Slate come from the Board or a Nominating Committee? This was answered above in question 1.
- 3) Are the Nominations open to other names? Yes. Either by petition or floor. For the petition, five members must sign a petition along with the written consent of the nominee. Nominations from the floor are taken at the April membership meeting, any member may be nominated as long as they do not object. If the nominee is not at the meeting, then they must send their written consent to the April meeting.
- 4) Will we hear a platform and goals? Depends on if we have an interest. We can propose it at the March or April meeting. We want our members to feel included.

Can conformation Class Dates be put on the Calendar? - It is up to the Chair to get information to the Web Master.

Following several brags the meeting was adjourned at 8:15pm.

# Land/Building Committee Report.

We have finally concluded the purchase of 7.81 acres from Mr. S Mebane. The cost of this land was \$11,000 per acre for a total purchase price of \$85,910. The club financed \$68,000 through First Citizens Bank at a rate of 6.75% for 10 years, the rest (\$17,910) coming from DKC savings.

The first phase of the club's development plan is to clear and seed about 5 acres and clear a 60 foot wide access to the new land. This access will start at the property line at the left side of the building and continue to the new land. We will also thin out trees on this side so we can have shaded parking and maybe set up a picnic area. On the right side of the building, we are planning on clearing the land from the building back 150 feet. This will allow future building expansion. We will also be leaving some trees in this area for parking. We hope to complete this phase this year (2006).

The second phase will to set up two agility rings on this new land. Suggested ring size for these rings is 120 feet x 120 feet. These rings will be fenced and hopefully lighting installed so these rings will be usable for evening SHO-N-GOs, agility classes and any club member wanting use of these facilities. This phase will be completed by the spring of 2008. Use will depend on how well the grass comes in and the land stabilizes.

The third phase will be to sell the Harris Road property. The property (about 18 acres) will be sold at the going rate at that time. The proceeds from this sale will pay off any balance of our outstanding loan. This phase is to be completed by year end 2009.

The fourth phase which will start in 2010 will be to add an extension to your present building.

The land/building committee is looking for input from DKC members on this plan and any other ideas the

members would like to see incorporated into the club's long term plan.

# **AKC Delegates' Meeting**

March 13 and 14, 2006, New York City, NY: Discussion items at the All-Breed Committee meeting centered mostly on dog show entries. With regard to Conformation show, statistics show that entries at All-Breed shows are not shrinking and that from last year to this total entries are within one hundred of one another. Major factor in entries continues to be the judging panel. In the past three years, eighteen new clubs have been licensed (six on the fast-track and one reinstatement) and only nine clubs have failed.

However, performance entries are down. It had been hoped that Rally would stimulate interest in Obedience. As yet this has not happened, and, in fact, is taking away from Obedience entries. The hope continues that individuals who begin in Rally will continue on to showing in Obedience. Statistics are being collected and will be available at the next meeting with regard to whether we are actually bringing in new exhibitors with Rally or just dividing up the pie with existing exhibitors switching to Rally from Obedience.

Limited Registrations was the focus of the Dog Show Rules Committee. Dogs on limited registrations are being entered in shows. They are ineligible and as such are disqualified affecting the number of dogs defeated and championship points awarded. By adding an "L" after the registration number, superintendents would be able to catch the limited status at time of entry. Alternatively, eliminating Limited Registration all together would as well. Eliminating Limited Registrations will be an agenda item for the June meeting.

The committee discussed the issue of penalizing dogs who win Best of Breed and do not stay to compete at the Group level. Group winners must stay for Best in Show, so why are BOB winners not required as well? The Canadian Kennel Club penalizes by withholding championship points from any dog not competing in Group.

The committee will be revisiting the sliding championship point scale. At present, the calculation is based on a three years average and every show is included in the calculation except National Specialties. The increase/decrease of number of dogs required can only move by 20 percent per year. The questions were raised about companion specialties after the National as well as dividing the country into regions differently than currently. It was agreed that the system is antiquated and needs to be reviewed.

Highlights of the President and Chairman's comments include:

- •The Balance Sheet is the strongest in the history of the AKC and 2005 was the second best financial year showing \$11.5 million in income.
  - Revenue was \$72.7 million—1 percent above last year even showing 3.5 percent decrease in registration (Registration revenue was \$35.5 million)
  - Fees were 7 percent higher
  - Publication income was up 13.5 percent
  - Interest and dividend income was up \$500,000
  - Expenses were 2 percent higher than the previous year
  - Payroll up 1 percent
  - Balance Sheet Items
    - ■Total Assets up \$10 million
    - ■Total Liabilities down \$900K
    - ■Total Net Assets up \$11.5 million
- New Services Available to Member Clubs on AKC website (www.akc.org)
  - AKC Syndicated Column contains editorial content that can be utilized by member clubs for inclusion in their newsletters and websites without charge

- Twenty minute power-point presentation is available to enhance membership and for use at education and information booths at shows
- AKC Archives is acceptance of one of a kind documents is now available to all member clubs
- Canine Legislation information and activities can be accessed on the AKC website including information for sending correspondence to legislators
- AKC expanding booth activities at shows
- AKC spokesperson is available for coaching and helping with geographic media lists
- Member clubs can set up a Quick Poll on the AKC website to accumulate information

Directors elected to the 2010 class are David Keene, Plano, TX (Greater Collin Kennel Club) Dr. William Newman, Bedford, PA (Mastiff Club of America), and Nina Schaefer, Huntingdon Valley, PA (Back Mountain Kennel Club)

Revision of the AKC seal to include "Founded 1884" was approved by the Delegate body. Clubs can phase in the new seal in order to utilize their current stock.

Both pros and cons were included in the discussions of eliminating the AKC Nominating Committee and allowing professional judges as delegates. Vote on these issues will be at the next meeting.

The next Delegates' meeting, is scheduled for June 12 and 13 in Raleigh, NC

All of the DKC land was inherited from William S. Terry by James Marion Terry. (Will Book 3 Page 85)

John W. Terry died in 1952 (Admin B 16, Page 214). His 2 children were Mary T. Mebane and John S. Terry.

James Marion Terry died in 1963 (Will Book 14 Page 106)

He devised a large tract, including Tracts One and Two, to his nephews, Thomas Terry and John S. Terry, and they later divided it between themselves. He devised the William S. Terry Homeplace, north of Guess Road, including Tract Three, to his niece, Mary T. Mebane. She told me that when that house was torn down, the chimney cornerstone was engraved 1850, so the land had been in the Terry family since at least the middle of the nineteenth century).

The deed calls the conveyance 5 acres, but describes a tract that measures 6.97 acres. Several weeks after the deed was executed, DKC signed a deed of easement to the Terrys, to allow them to use the driveway, B 403 P 430 this driveway is 1.97 acres, shown as Tax ID # 189200. The recombination map does not now include the driveway. My Terry owning the easement to the driveway, has been paying the tax on this parcel.

Tract Two: 14 acres to the south of Tract One, containing creek and flood plain; this was purchased to increase the DKC permeable surface percentage to allow additional building on other land.
