Cairn Terrier: Dog of the Month

Terrier Group



The appearance of today's **Cairn Terrier** is an attempt to preserve the form of the old-time working terrier from the

Isle of Skye. This was a working terrier with the courage to bolt otter, foxes and other vermin from the rocks, cliffs and ledges on that isle. He is not as low to the ground as the Sealyham and the Scottish Terrier.

The Cairn is adaptable, but restless and curious about any disturbance. He does not start fights, but will finish if attacked. He is affectionate and can be jealous of his owner's attention to another. This is the easiest of the terriers to leash train. *Toto,* in the *Wizard of Oz* was a Cairn Terrier.

Background: All terriers were grouped together in Scotland until 1873. The Scottish, West Highland and Cairn were then placed in a Skye Terrier classification. They developed from the same stock, originating in the islands and highlands of Western Scotland. The 3 were often found in the same litter, differing only by color. The Cairn standard England Terrier in permitted white as a color until 1923. In 1917, the AKC barred any Cairn from registration that was a mixture of West Highland White and Cairn.

AKC Approved May 10, 1938.

Show Ring: *Weight*: Bitches-13 lbs; dogs-14 lbs. *Height* (withers): Bitches-9½"; dogs-10". Older dogs may weigh slightly in excess and growing dogs may be under these weights and measurements.

Eyes: Set wide apart, medium in size, hazel or dark hazel in color. Ears: Small, pointed, well carried erectly, set wide apart. Bite: Neither overshot nor undershot. Coat: Must be double-coated with profuse harsh outer coat and short, soft, close furry undercoat. Cairns are not trimmed except for minor touch ups. Nose: Black. Tail: Carried gaily but must not curl over back. The tail is not docked. Color: May be of any color except white. Dark ears, muzzle and tail tip are desirable. Feet: Forefeet larger than hind feet.

Breeding and Whelping: No particular problems.

Faults: Deviations from standard.

Disqualifications: None.

Recognized Problems: Globoid cell leukodystrophy (Krabbe type) which is a demyelinating disease. This is seen in puppies of a few weeks to a few months. Cranial mandibular osteopathy, inhalant allergies, a higher incidence than usual of cryptorchidism.

Old Age: The life of the Cairn is long if not afflicted with any of the above mentioned problems.

Durham Kennel Club Membership Meeting – May 15, 2006

Following a program of "Meet The Candidates" where the DKC members on the nominating slate were given 2-3 minutes to say what was in their Bio or more, President Steve Wallis called the meeting to order.

President: Welcome to any visitors and please stand up and tell us about yourself. Steve is not running for re-election. It was a hard decision to make. You will find that who is elected for President will make a fine President. Thank you for all of your support.

Treasurer: DKC Account Balances as of 5/15/06:

Some expenses are still outstanding for both the Spring Show and the Spring Agility Trials.

AKC Delegate: Items for consideration at the June Delegates' Meeting include:

Vote on amendment to Article VI: Delegates which could have some impact on the pool of possible Delegates by eliminating the restriction to professional judges.

Vote on amendment to Article VII: Board of Directors Nominating Committee to add a revision eliminating the Nominating Committee. Any Delegate, including incumbent Board members, may run by petition. Number of signatures raised from twenty to fifty and a six-week window All candidates will be proposed. known before the December/January Delegate Meeting.

Discussion of revision to Article VI: Delegates, Section 5 which would

prohibit those with a significant interest in organizations that are in competition with AKC from becoming part of the AKC's governing body.

Discussion of revision to Chapter 16, Section 4 of the Rules Applying to Dog Shows which would clarify the Championship requirements (the amendment states that of the 15 points, two wins of three or more points are required under two different judges; the remaining points must be won under at least one other judge).

Discussion of revision to Chapter 3, Section 8 of the Field Trial Rules and Standard Procedures for Retrievers which would reduce the conflict distance between trials to 200 miles from 350 miles

Discussion of revision to Chapter 14, Sections 9 and 10 of the Field Trial Rules and Standard Procedures for Retrievers to ensure the correct clarification of stakes involved.

Discussion of revision to Chapter 14, Section 10 of the Field Trial Rules and Standard Procedures for Retrievers to encourage interested hunting test competitors to enter and compete in licensed field trials. (An Owner-Handler stake may be run without a companion Derby Stake)

Discussion of revision to Chapter 14 Section 11 of the Field Trial Rules and Standard Procedures for Retrievers to provide authorization for an earlier start and consequently additional time to complete the stake.

Discussion of revision to Chapter 14, New Section 18 of the Field Trial Rules and Standard Procedures for Retrievers to provide rules governing junior handlers.

Annual Vietnam/All Veteran's Reunion

"The Place: The reunion was held in Melbourne, Florida at a beautiful, huge park. This is a public park with facilities. camping/RV а big swimming lake and locations for many varied family activities and sports. There also is a dog park and although it seemed to be very well supervised and did get a lot of activity, the night before I arrived, I was told, there was an alligator found inside the fence at the dog park. I found no reason to check that out further!

The Reunion: From all parts of the country they came, many with gray hair streaming down their back, limping. some some using wheelchairs and/or leaning on canes. They were there from all branches of military service. Many wore leather and camo attire displaying information regarding the unit they served in and the dates of their tour of duty. The young were there too, present day warriors, some having returned deployment and some waiting to be called back...to the 'sandbox' they call it. Over 100,000, civilians and military personnel would attend the week long event, there to remember, to enjoy the military displays and to share memories. Everywhere I looked I was face to face with a hero. This was my third year to attend and it was an honor for me to be there again. Cody and Jet were with me.

It is a trip that many make every year. There to renew old friendships, to mourn the ones not able to be there, and to share memories of the horrors they endured and survived. There were great bear hugs and smiles as familiar faces were found, a year older, but easy to recognize.

Motorcycles, hundreds of them, crept into the park honoring signs that said, "Hallowed ground, please keep noise down." The riders muted their machines, so quiet they barely

made a sound as they glided along. Early in the week a replica of the Vietnam Wall in Washington D.C. was brought in with a motorcycle escort stretching close to 7 miles. As the Wall was erected and put into place a hush fell over the park. People slowly walked along the Wall whispering as they pointed to names. Many knelt and placed a small American flag or a bunch of flowers below a name they had been searching for. There was a '60 something VW Bug on display, kept in mint condition by a loving family eternally waiting for the return of their young soldier. His name is on the wall. A retarded man whom I met the first year I was there, rides his heavily decorated bike to the Wall every year to be sure his brother's name, a Marine, is still there. He smiles as he finds it again this year.

I attend because of my affiliation with Space Coast War Dog Association and I help as I can with their display booth. K-9 handlers, past and present, stop and look at the huge WarDog picture and information display and share stories of lives that have been saved, often their own, by our military dogs, up to 10,000 lives I have been told. The handlers revere the WarDogs and treasure their memories. I am often moved beyond words as I hear stories shared by men and women in tears and I watch as many kneel and gather my Cody into their arms. Cody isn't much of a hugger with strangers, but he knows when there is a need and responds. I am tremendously proud of him as I watch him give that gift. This was Cody's third visit too, and many who met him the first time asked for him by name.

At a much anticipated and designated time, a Huey and a Black Hawk helicopter circle the area and one hovers and dips in a silent salute above the Wall. At the first sound of the rotors overhead, before we see them, a man standing next to me said, "that's the best sound in the whole world, they either

bring in supplies or are there to pick us up." His emotion was palpable.

This event is attended by thousands of civilians, along with the military and many families who come to visit the exhibits. There are displays of all types of military equipment that can be investigated, climbed into and onto and of course there are people there to explain and answer questions. Vendors are there aplenty, with military clothing and memorabilia for sale and food booths to rival our own state fair.

Some of you may recall having heard about a WarDog named Fluffy who's handler fought a long and hard fight to bring Fluffy home. I met Fluffy and his family at the reunion. Fluffy is becoming acclimated to civilian living and is enjoying the good life now with his handler, his handler's wife and two young girls. Fluffy is a serious working dog and is a bit short on social skills, but his family is working hard socializing him and each day makes him a little more at ease. I was proud to meet Fluffy, to be able to pet him, and happy to know that he is home now forever, with the people who love him the most.

I thank Steve for asking me to share this experience with our membership. Now when you see me wearing something sporting a Space Coast logo you'll know a bit of what it's about. This also gives me the chance to thank those of you who have supported this project, many right from the start. It's been a very meaningful involvement for me and I am grateful for your encouragement and support.

A final note: PBS was at the reunion filming and interviewing several who are involved with the WarDogs. I have asked to be told when this documentary will be shown and if possible, will let you folks know when that will be.

AKC Delegates' Meeting, June 11 and 12, 2006 Raleigh, NC

The All Breed Committee continued discussion regarding new AKC member clubs; are there too many clubs and increasing number of shows that are eroding the attendance at each one? The recent study shows that for the past four years, the total number of dogs shown has changed by only 61 nationally. In this period of time 33 new clubs have been licensed and applications are in process for additional clubs. Subcommittee has been formed to determine whether the process for new club approval and requirements.

Locating show sites continues as an issue for member clubs. With the trend in more and more clubs changing dates and show locations to form clusters, the AKC has determined that if a club has not held a show in their territory for two consecutive years, another club may move into the territory and hold their show.

Guidelines have been established for the telecast of dog shows. The policy will be sent to all show-giving clubs. Member clubs are being asked to appoint a Legislative Liaison. AKC Legislative Department will provide training and information to those individuals who are interested.

The discussion at the Dog Show Rules Committee continued discussion of additional classes. The current thought about Amateur Handlers is that this will become a class and replace the Novice Class, be set up with a ranking system, and be recognized beyond class competition with an invitation to the AKC Eukanuba Invitational. The Breeder Class will stay as a Special Attraction Class at National Specialties.

Surveys have shown that most exhibitors are in agreement that Groups are too large, and with new breeds being approved they will continue to grow. There are currently seven hounds on the list for approval. Under first consideration is the establishment of a Spitz or Northern Breed Group. Parent clubs are in agreement.

Several changes to the Rally competition were presented at the Obedience, Rally and Agility Committee Meeting. New language has been added to the narrative of exercises defining the principal parts of the exercise that must be done to gain credit for the performance of the station. A minimal number of new signs are being added to the current list and the development of new non-regular class exercises signs are still in development. Changes are recommended to the height of the high and/or bar jumps as well as to some of the Rally regulations. It has

been proposed to bring the judging to twenty-two dogs per hour, which would necessitate a change to the number of retries of an exercise from two to one. Implementation of new changes is slotted for July 2007.

The AKC Rally Department is inundated with requests for new exercises and the development of new non-regular classes, utilization of new signs. One of the non-regular classes currently under consideration is a Transition Class. This class would be used as a transition between Rally and Obedience. The class would be judged stricter than a regular Rally class and more like a Novice Obedience class.

From a statistical standpoint, Rally has shown the largest growth, increasing 69.5 percent from last year. 13,000 titles were earned in 2005; 5,000 earned for the first third of 2006. Agility has increased 12.3 percent over last year and Obedience entries up 6 percent. One of the initial studies has shown that many exhibitors are leaving Obedience at the Open level and completing their Rally titles and then returning with a new attitude and with a dog that's happier and more willing to work.

AKC has received significant correspondence expressing concern about the new Judges' Conflict of Interest Policy. The Board is looking into adding to the list of current exemptions. In the mean time, any judge may request permission to judge at a venue and any organization may ask for exemption. The policy is being reviewed for possible exemptions for all performance and companion event judges. As a note, there has always been a policy in place that a judge needed to inform the AKC if they are judging for another venue.

The AKC website now includes many free online services for member clubs that can be found in the gray and brown toolbars on the home page. These services include Club Events Management Electronic Agility Club Communications submission, (newsletter articles, photos, etc), Public Service Announcements and Publicity Tools in PDF format, AKC Logo access, Breed Fliers, Public Education information, Legislative Rule and Regulations Booklets. Parent Clubs may access the Show Site Locator, Electronic Stud Book, and New Titles of Record report. Exhibitors can customize their information using My AKC.

Highlights of the President's and Chairman's Reports include:

- An Archivist has been hired to assist the AKC and Member Clubs maintain records.
- The Board of Directors has established a \$100 million

- endowment reserve as indicated by the auditors. When the reserve reaches this value, the income will assist funding the AKC as necessary.
- Operating Profit is 5 percent lower than the same period last year.
- Registration Revenue continues on a downward trend; 5 percent lower than last year.
- Registrations in 1981 represented 96 percent of income; 2005 represent 53 percent.
- Number of registrations peaked in 1992 at 1.5 million; 2005 were .9 million, down 40 percent.
- In 1992 AKC was primarily the only registry; 2005 there are 23 competing registries.
- Core Business activities (registration, events, subscriptions, DNA) lost \$3.4 million last year; Non-core activities (credit cards, merchandise, pet insurance, licensing) operated at a \$10 million profit.
- Event Revenue in 2005 was \$7.4 million, event expense, \$17.2 million, representing a \$9.8 million loss.
- Conformation lost \$3.9 million
- Performance events lost \$3.2 million.
- Companion events lost \$2.8 million.
- Total entries at events during 2005 were 3 million — revenue per entry was \$2.60 and expense \$5.75 showing a loss per entry of \$3.29.
- In an effort to increase registrations, the AKC is offering electronic coupons to dog.com, free 60-day pet insurance, litter coupons, on-line registration, and public education.

Recent print articles issued by the AKC Public Relations Department involve registration statistics. Articles were published in USA Today, Time, Washington Post, NY Times and National Geographic for Kids. These articles were published in the largest 50 US cities and were customized for the top ten breeds registered in each city. Detroit was the only city where the Labrador Retriever was not the number one registered breed — it was the German Shepard.

Revision of the Amendment to eliminate the restriction of professional judges serving as delegates was defeated.

Revision of the Amendment to eliminate the Nominating Committee was sent back to committee for review and revision.

The next Delegates' meeting is September 11 & 12, 2006 in Newark, NJ.
