# The Obama Family Dog Saga

Why has it taken so long? Because the type of dog they want doesn't often turn up at the local shelter.

Why has a task as simple as getting a dog eluded the Obamas for so long? Perhaps the answer can be divined in Michelle Obama's interview: She said she wanted not just any Portuguese water dog but a rescued one. An adult with a good temperament. Perhaps even housetrained. Certainly that should satisfy the activists agitating for the Obamas to adopt a stray. The rescue-only crowd insists that every dog purchased from a breeder is a death sentence for a stray. They make nο distinction between responsible breeders who nurture sound-tempered dogs and puppymill operators who crowd breeding bitches so tightly into cages that they chew off each other's legs.

For the record, I rescue dogs. I rescue, in fact, the kinds of dogs that end up in shelters in droves. I am well set up for the task. My tolerant, dog-loving husband and I have no children; I love dogs that would drive sane women mad; and I have the tenacity to work with them. But I also love purebred dogs and the whole notion that we humans have bred dogs for certain tasks. And I despair that we may be heading into a world in which breeding dogs to do what dogs do -- work with, and beside, and indeed even for, human beings -- is considered, by some crooked measure, cruelty to animals. There is something far worse than a family acquiring a dog from a conscientious breeder, and that's a family rescuing a dog that turns out to be fundamentally unstable or just plain

unsuited to life with a family. Childhood dogs shape attitudes toward animals for life; they can make kids lifelong advocates for animal welfare or create in them an ineluctable fear.

Symbolically, it would be nice if the Obamas could rescue a dog. But to insist that the only good dog is a rescued dog is to relegate our future with the canine species to random relationships in which humans are forced to settle for whatever renegade breeders produce and fail to care for. And let it be said that the reason there exists such a thing as a Portuguese water dog at all, or any dog with a hypoallergenic coat and a game temperament, is not a happy accident but a triumph of the selective breeding humans have been practicing with canines for millenniums -- the very practice so many people who claim to care about dogs would prefer to see turned into a crime.

**Legislative Proposals** 

Two statewide legislative proposals loom before North Carolina dog owners and breeders. The first, HB733, seeks to regulate the "commercial breeding of dogs." The second proposal, HB626, seeks statewide restrictions on tethering dogs.

HB733, which supporters hope will go in effect on 12/1/09, defines a commercial breeder as "any person who, during any 12-month period, maintains 15 or more adult female dogs for the primary purpose of the sale of their offspring as companion animals." A "commercial breeding facility" is defined as "the physical location or facility at which a commercial breeder breeds or maintains adult female dogs and their offspring. For purposes of this Article, commercial breeding opera-

tions shall not include those kennels or establishments operated primarily for the purpose of boarding or training hunting, sporting, herding or guide dogs."

Some of the proposed restrictions on breeders include, but are not limited to:

- \* Mandatory annual licensing at a cost of \$50.
  - \* Age limits on breeding dogs
- \* Annual certification by a veterinarian that a dog can be bred
  - \* Unannounced home inspections
- \* NC Board of Agriculture devised standards of care, including exercise, veterinary care, housing, and record-keeping
- \* Prescribed methods of transporting animals to and from the "commercial breeding facility" (remember, this facility could easily be the breeder's home.)
- \* At no time would a breeder be allowed to have possession of more than 20 bitches over the age of 4 months

Breeders found to be in violation of the imposed restrictions, or who declined a home inspection would find themselves subjected to fines and possible seizure and euthanasia of their dogs.

The second bill, HB 626, is also set to come into effect on 12/1/09, and seeks to restrict the tethering of dogs statewide. The bill defines tethering for more than nine hours as animal cruelty. During this nine hours, any tether used must be fifteen feet or longer in length. Below please see a copy of the letter the DKC has sent in opposition to HB626. [next page]

## A copy of the letter the DKC has sent in opposition to HB626

#### Representatives;

Comprised of over 250 members, the Durham Kennel Club (DKC) has been promoting the care and welfare of North Carolina's dogs for over thirty-nine years. Through owner education and community involvement, the DKC has striven for the betterment of all dogs, regardless of their background. The DKC officially opposes legislation limiting the rights of responsible dog owners to keep dogs in a humane manner, including anti-tether legislation. Where there are already laws in place dealing with neglect and animal cruelty, there is no need for further legislation to address the same issues.

The North Carolina Animal Cruelty ordinance currently in place states:

"If any person shall intentionally overdrive, overload, wound, injure, torment, kill, or deprive of necessary sustenance, or cause or procure to be overdriven, overloaded, wounded, injured, tormented, killed, or deprived of necessary sustenance, any animal, every such offender shall for every such offense be guilty of a Class 1 misdemeanor..."

Considering that it is entirely possible, indeed easy, to tether a dog while exceeding all of the stated conditions above, it is contradictory to define tethering in and of itself an act of cruelty punishable by law. Every "issue" typically broached in support of proposed anti-tether legislation is already addressed by the current animal cruelty laws: adequate shelter, veterinary care, food and water, waste removal, etc. Dogs tethered in a manner inconsistent with existing laws are already protected under said laws. We support the cruelty laws as they stand now and fully condone continued efforts to enforce them against those that choose not to comply. Those dog owners who keep their dogs responsibly on tethers, meeting all the requirements of the law, should not be penalized for the negligent actions of those who choose not to abide by the law.

Anti-tether bills, such as this one are couched in emotional appeals and personal anecdotes, rather than being based on factual evidence. Pictures of starving puppies on heavy chains are used to sell a horror story, one that is not represent-ative of the norm, to well intentioned, sympathetic dog lovers, the majority of which keep their dogs strictly inside as house dogs. It is entirely possible to tether a dog responsibly in a manner consistent with, and even above and beyond, all existing levels of mandatory care. Whether an outdoor dog lives in a kennel or on a tether, the obligation exists to keep the dog responsibly, which is contingent upon a combination of love, and common sense – neither of which can be created through legislation.
