## The Secrets Inside Your Dog's Mind (by Carl Zimmer, Time.com, condensed )

(September 21, 2009) Brian Hare, assistant professor of evolutionary anthropology at Duke University, holds out a dog biscuit.

"Henry!" he says. Henry is a big black schnauzer-poodle mix--a schnoodle, in the words of his owner, Tracy Kivell, another Duke anthropologist. Kivell holds on to Henry's collar so that he can only gaze at the biscuit. "You got it?" Hare asks Henry. Hare then steps back until he's standing between a pair of inverted plastic cups on the floor. He quickly puts the hand holding the biscuit under one cup, then the other, and holds up both empty hands. Hare could run a very profitable shell game. No one in the room--neither dog nor human--can tell which cup hides the biscuit.

Henry could find the biscuit by sniffing the cups or knocking them over. But Hare does not plan to let him have it so easy. Instead, he simply points at the cup on the right. Henry looks at Hare's hand and follows the pointed finger. Kivell then releases the leash, and Henry walks over to the cup that Hare is pointing to. Hare lifts it to reveal the biscuit reward.

Henry the schnoodle just did a remarkable thing. Understanding a pointed finger may seem easy, but consider this: while humans and canines can do it naturally, no other known species in the animal kingdom can. Consider too all the mental work that goes into figuring out what a pointed finger means: paying close attention to a person, recognizing that a gesture reflects a thought, that another animal can even have a thought. Henry, as Kivell affectionately admits, may not be "the sharpest knife in the drawer," but compared to other animals, he's a true scholar.

This fall, Hare is opening the Duke Canine Cognition Center, where he is going to test hundreds of dogs brought in by willing owners. Marc Hauser, a cognitive psychologist at Harvard University, recently opened his own such research lab and has 1,000 dogs lined up as subjects. Other facilities are operating in the U.S. and Europe.

The work of these researchers won't just satisfy the curiosity of the millions of people who love their dogs; it may also lead to more effective ways to train ordinary dogs or--more important--working dogs that can sniff out bombs and guide the blind. At a deeper level, it may even tell us something about ourselves.

The Obedience/Agility/Rally Committee discussed the Mixed Breed program, as its effective date is October 1, 2009. Mixed Breeds are eligible to compete in stand-alone companion events.

Regarding deaf dogs competing in companion events, the committee as a whole has no objection; however, there are concerns. The AKC is the only organization that bans deaf dogs from competition. The Board of Directors asked staff for their review, with the result that staff will not, at this time, recommend the request, as they believe it to be a doorway for all handicaps, including blind, three-legged, and/or paralyzed dogs. The committee passed motion affirming their support to be brought before the Board of Directors.

The committee passed motion to bring to the Board of Directors the recommendation to change the judging limitations from 30 days, 200 miles to 30 days, 100 miles for obedience trials, effective immediately.

New titling classes, as well as non-regular classes, are included on the paper Show Trial Application. These classes are not yet available on the on-line form.

Initiative is underway to get 4H clubs involved and up to speed with the new Mixed Breed Listing program. Currently there are more than 400,000 dogs enrolled in 4H Clubs. The possibility of new junior-specific classes is being investigated.

At the Delegates' Forum, presentation was made concerning the Grand Champion conformation title. This title came from a staff initiative. Four dogs could be awarded Grand Championship points: BOB, BOS, Select Dog, and Select Bitch. The title would require 25 points, two majors, and minimum two judges. To be eligible for points, the dog must be a champion of record and entered in the Best of Breed class. Change is being considered to allow Champions of record who are entered in Non-regular classes, i.e. Hunting, Working, Veterans, also be allowed to compete for Grand Championship points. The Board is looking for approval at the

December Delegates' meeting for implementation in May 2010.

August year-to-date compared to August 2008 financial highlights

- Operating revenues down 11%, or \$5.2 million
- Operating expenses down 6%, or \$2.6 million
- Operating profit \$854K, compared to \$3.5 million

The President's Report discussed the Meet the Breeds event to be held in NYC in conjunction with the Cat Fanciers Association. Sixteen corporate sponsors and 146 parent clubs will participate. Individuals can check out meetthebreeds.com for games, interactive activities, and a dog vs. cat poll. In conjunction with the Boy and Girl Scouts, a Pet Ownership Patch can be earned. Eighty-seven legislators will serve as honorary chairs.

The Chairman's Report covered the 125<sup>th</sup> Anniversary of the AKC. Since its inception in 1989, the Canine Good Citizen program has had more than 600,000 participants. The Anniversary show in Long Beach will be the ultimate dog show with 130 parent clubs holding specialties or supported entries in conjunction.

At the recommendation of the Board of Directors, the Delegates voted to refer back the proposed amendment to split the Sporting and Hound Groups, change the name of the Non-sporting Group to Companion Group, and establish a new Northern Group. This recommendation was made due to letters from three parent clubs. This proposal will be returned to the Delegate body at the March 2010 meeting for vote or further consideration.

The delegates adopted items for vote:

- Proposed amendment to Chapter 3, Section 5 of Rules Applying to Dog Shows – Dog Show classifications, which would permit the further division of the 12-18 month class at the option of the individual club (effective Jan 2010)
- Proposed amendment to Chapter 8, Section 9 of Retriever Field Trial Rules, which would update the wording to address all contagious/communicable diseases.

Proposed amendments to be voted at the next Delegates' Meeting

- To Chapter 3, Section 8 of Rules Applying to Dog Shows – Dog Show Classifications, bringing the Bred-by-Exhibitor requirements in line with all other regular classes as defined by Chapter 11, Section 1.
- To Chapter 3, Section 1 of Beagle Field Trial Rules and Standard Procedures for Brace, Small Pack and Small Pack Option Field Trial and Two Couple Pack Hunting Tests, granting license status to events held by Beagle Field Trial Federations.
- To Chapter 9, Section 1 of Beagle Field Trial Rules and Standard Procedures for Brace, Small Pack and Small Pack Option Field Trials and Two Couple Pack Hunting Tests, allowing a Field Trial Committee the option of combining the small Beagle Field Trial Class (13") with the other size class (15") from the same gender.
- To Chapter 3, Sections 1 and 15, of Rules Applying to Dog Shows – Dog Show Classifications, allowing for awarding Grand Championship points to Best of Breed or Best of Variety of Breed, Best of Opposite Sex to Best of Breed or Best of Variety of Breed, Select Dog, and Select Bitch; and to Chapter 16, Sections 1-7 of Rules Applying to Dog Shows – Championship and (a new) Grand Championship Awards, allowing for the creation of awards for the above listed titles.

The next Delegates' Meeting will be held in Long Beach, CA, December 14 - 15, 2009.
