Pet Products Get the Tech Treatment (by Steve Mollman, CNN, condensed)

(December 17, 2009) Gadgets are not soft and cuddly, and there are no downloadable upgrades for slobbering mutts. But with enthusiasm for pets growing unabated, and technology digging ever deeper into our lives, the two seemingly unrelated worlds increasingly touch.

In the US, total spending on pet products topped \$43 billion last year, according to the American Pet Products Association. It projects the figure will be about \$45.4 billion for this year (that's bigger than the GDP of Kenya.)

But where technology excels is in addressing the two big worries of pet ownership: fear and guilt. Most owners dread the day their pet gets lost. Enter GPS pet tracking, offered by companies like Zoombak, Garmin, and Positioning Animals Worldwide.

This summer the latter launched the SpotLight GPS pet locator, which fits on a collar. If you lose your pet, you can not only check Google Maps to see where it is, but get turn-by-turn updated directions on your phone. You can also get email alerts whenever your pet strays outside a safety zone that you designate.

Meanwhile the Micro ID Rescue Collar contains a tiny USB flash drive that somebody who's found a lost pet can plug into a computer to find care instructions and the owner's contact details.

But for many pet owners, fear is outweighed by guilt about not giving pets enough company and attention.

The Talk to Me Treatball has them in mind. Released this year, it records and plays voice messages from the owner and dispenses treats at random when it's rolled around, so a pet presumably feels reassured when alone.

An iPhone app called Pet Acoustics, from a company of the same name, plays music customized to the hearing sensitivities of dogs, cats, or horses. Online reviewers

describe leaving the music on at homes when pets are alone, or using it during car trips to soothe canine nerves. Released in October, the app has been downloaded in more than a dozen countries.

Another aspect of owning pets is wishing you could know what they think, or what they do when you're gone. Addressing the former desire is the Bowlingual Voice communicator.

With this, a handheld unit wirelessly linked to a microphone on the dog's collar translates each bark into one of six canine emotions, which it reads aloud. Not everyone agrees it works as advertised, but Japanese toy maker Takara Tomy claims there is solid science behind it.

Many owners want to see what their pets get up to when they're gone, so webcams come to mind.

HighlightCam, launched this year, condenses video down to the highlights, like when Rover opens the fridge for the turkey leftovers. Users can get email alerts and then go online to see what just happened.

Catching Rover in the act is fun, but "it's sometimes recommended by dog trainers for diagnosing things such as separation anxiety," points out Boutelle at Dogtec.

Roasted Red Pepper Potato Soup (Dana Mackonis) Servings: 6-8
From *Simply Recipes* (<http://simplyrecipes.com>)

- 2 large red bell peppers
 - 3 large russet potatoes, peeled and quartered (about 5 cups)
 - 1 medium yellow onion, peeled and diced (about 1 cup)
 - 3 cloves garlic
 - 2 qt chicken (or vegetable) stock
 - 1 cup hot milk or cream
 - 1/4 cup butter (1/2 a stick)
 - Cayenne, salt and pepper to taste
- Roast the red bell peppers until blackened on all sides. (Use a grill, cooktop gas burner, or oven broiler.) Place the blackened pepper in a bag, close, and steam the pepper for 10-15 minutes, or until the skin feels like it can easily be slipped off. Remove from the bag, peel off the blackened skin, remove the seeds. Cut into strips.
- Place pepper, potatoes, garlic, and onion in a large soup pot and add stock. Cook over medium-high heat until potatoes are soft.
- Add hot milk (or cream) and butter. Purée in a blender or food processor until very smooth. Add cayenne, salt and pepper to taste.

More Recipes

More recipes from December's Rally/Obedience Show...

Macaroni with Ham & Cheese *(Eileen Bassett)* Servings: 6-8

- 1/2 lb elbow macaroni (about 2 cups)
 - Salt to taste
 - 3/4 lb cut up cooked ham (2 cups)
 - 2 cups sliced mushrooms
 - 8 oz sharp cheddar cheese
 - 3 TBSP butter
 - 1 TBSP flour
 - 2 cups milk
 - 1/8 TSP nutmeg
 - 1/2 cup chopped onion
 - cayenne pepper
 - 1 cup heavy cream
 - Parmesan cheese
- Cook macaroni and spread in a greased 9"x 12" inch pan.
- In a saucepan melt 2 TBSP butter and add flour; then add the milk, cheese, nutmeg, salt, and pepper to taste.
- In a skillet melt the remaining butter. Saute the onions and mushrooms, then add the ham, cheese sauce, cayenne, and cream.
- Pour over the macaroni and sprinkle the parmesan cheese over the top.
- Bake in a 400° oven until bubbly and the cheese browns.
- (Can be made in advance and kept in the refrigerator or freezer.)*

Triple Chocolate Chunk Cookies *(Nicki Camerra)*

- 2 sticks of butter, softened
- 1 cup dark brown sugar
- 1/2 cup white sugar
- 2 eggs
- 1 tablespoon vanilla
- 1/2 cup canola oil
- 1 cup flour
- 1 cup whole wheat flour
- 1/2 c unsweetened cocoa powder
- 1 c semi-sweet chocolate chips
- 1 cup milk chocolate chips
- 1 cup walnuts

Mix together butter and sugars with electric mixer. Add in oil, eggs and vanilla and mix until smooth. Blend together dry ingredients- add slowly to the butter/sugar mixture using the electric mixer. Add in chocolate chips and nuts. Roll into balls and flatten slightly with your palm. Bake at 350° oven for 12-15 minutes. Cookies should still be soft in the middle.

AKC Delegates' Meeting, December 2009

The AKC Delegates' Meeting was held December 14-15 2009, in Long Beach, CA.

The Obedience/Rally/Agility Committee discussed allowing deaf dogs to compete in Companion Events. Other organizations do allow for deaf dogs to compete, however, at present, the AKC does not. The Dalmatian Club is vehemently opposed to a change. Consideration might be given to age-related deafness in Veteran Classes.

Several Obedience Regulation changes became effective January 1, 2010. These are posted on the AKC website, and include allowing clubs to host two obedience trials on the same day, obedience teamwork a non-regular class, and allowing competitors to move from A to B class if entered incorrectly. On July 1, 2010, the new optional titling class, Beginner Novice, will be available. Questions arose about order of judging. Titling classes can be held in any order. Non-regular classes must follow the titling classes unless a separate ring is available.

Mixed Breeds will be able to compete at stand-alone events on April 1, 2010. Currently there are 1395 mixed breed dogs on the listing and 504 events have been approved. Information is being printed on the back of the entry form with instructions for mixed breed dogs on how to enter. Judges can refuse to judge mixed breed classes, so clubs need to be aware of judge's position before they are hired.

Graduate Novice and Open classes are pulling larger entries than originally anticipated so it would be worthwhile for clubs to offer these to exhibitors. Also, the Wild-card classes seem to be treated by exhibitors as a Match Show. Obedience entries, in general, seem to have stabilized over the past year.

Agility Advisory Committee recommendations are currently being written up and hopefully will be brought before the Board of Directors in February.

The Delegates' Forum and meeting allowed for presentations by candidates for the upcoming Board of Director positions. Vote on the candidates will be at the AKC annual meeting in March. Candidates for election: Dr. Carman L. Battaglia, German Shepherd Dog Club of America; Dr. J. Charles Garvin, Marion Ohio Kennel Club; Steven D. Gladstone, Reno Kennel Club; Dr. William R. Newman, Mastiff Club of American Kennel Club; Patricia C. Scully, Obedience Training Club of Hawaii.

The Chairman and President's Report discussed the extremely successful Meet the Breed event in NYC with 36,000 attendees, and the AKC/Eukanuba event, which hosted 133 supported and/or regional specialties.

November year-to-date compared to August 2008 financial highlights:

- Operating revenues down 9% or \$5.8 million
- Operating expenses down 7% or \$4 million

- Investment gain of \$9 million, up 18% compared with a loss of \$17 million
- Total revenue from registrations down \$3.7 million or 13%
- Revenue from pedigrees down \$927K
- Revenue from publications down \$500
- Revenue from royalties down \$658K

Proposed amendments voted and adopted by the delegates:

- Chapter 3, Section 8 of *Rules Applying to Dog Shows – Dog Show Classifications*: brings the Bred-by-Exhibitor requirements in line with all other regular classes as defined by Chapter 11, Section 1 of these rules.
- Chapter 3, Section 1 of *Beagle Field Trial Rules and Standard Procedures for Brace, Small Pack and Small Pack Option Field Trial and Two Couple Pack Hunting Tests*: grants license status to events held by Beagle Field Trial Federations.
- Chapter 9, Section 1 of *Beagle Field Trial Rules and Standard Procedures for Brace, Small Pack and Small Pack Option Field Trials and Two Couple Pack Hunting Tests*: allows a Field Trial Committee the option of combining the small Beagle Field Trial Class (13") with the 15" class from the same gender.
- Chapter 3, Sections 1 and 15, of *Rules Applying to Dog Shows – Dog Show Classifications*: allows for awarding Grand Championship points to Best of Breed or Best of Variety of Breed, Best of Opposite Sex to Best of Breed or Best of Variety of Breed, Select Dog, and Select Bitch; Chapter 16, Sections 1-7 of *Rules Applying to Dog Shows – Championship* and (a new) Grand Championship Awards allows for the creation of awards for the above listed titles. This amendment was modified to allow spayed and/or neutered dogs to be eligible to compete for Grand Championship points. (Dogs will be able to earn Grand Championship points effective after the point schedule change in May of 2010.)

Proposed amendments to be voted at the next delegates' meeting:

- Chapter 10, Section 1-6, of *Rules applying to Dog Shows—Duties and Responsibilities of Show Veterinarians*: updates the requirements for show veterinarians to better accommodate on-call veterinarians and to require clubs to inform them of their duties; Chapter 15, Section 1, of *Rules Applying to Dog Shows—Protests Against Dogs*: includes the event committee in the process of removing dogs from the show, to eliminate the requirement of a form, and to assign the fiscal responsibility for veterinary expenses.
- Chapter 11, Section 6 of *Rules Applying to Dog Shows—Dog Show Entries, Conditions of Dog Affecting Eligibility*: eliminates the use of telegrams to change or cancel entries as telegrams are now obsolete.

The next Delegates' Meeting is the annual meeting and election of Board of Director Members to be held in Newark, NJ, March 8-9, 2010.
