# American Kennel Club News - Linda C Wozniak Nominate a Dog

Do you Know a CANINE HERO? NOMINATE A DOG FOR AN

AKC HUMANE FUND AWARD FOR CANINE EXCELLENCE!

New York, NY – To celebrate the dogs who do extraordinary things in the service of humankind, the AKC Humane FundSM is seeking YOUR nominations for its <u>AKC Humane Fund Awards for Canine Excellence (ACE)</u>. Nominations are open now through July 31st and winners will be announced in the fall of 2020.

Each year, the AKC Humane Fund pays tribute to five dedicated, hardworking dogs for making significant contributions to an individual or entire community. Since its creation in 2000, 100 ACE awards have been presented. Former ACE recipients have included a Poodle who helps his young autistic owner gain confidence each day and a Doberman Pinscher, who dedicates

his life to Search & Rescue despite his own battle with Wobbler's disease, among dozens of other extraordinary dogs.

"There are so many remarkable dogs to recognize with these awards," said Doug Ljungren, President of the AKC Humane Fund. "Canines touch the lives and hearts of their owners and the world around them each day. We are proud to honor five of them each year with an ACE Award in recognition of their contributions."

One award is given in each of the following five categories:

Uniformed Service K-9

Eligibility: Full-time working K-9s in the realms of city, county, state, or federal law enforcement; the military; firefighting; customs and border patrol; emergency services.

**Exemplary Companion** 

Eligibility: Dogs without formal training or certification that have nonetheless distinguished themselves in some way and have made a meaningful contribution to their owners or communities.

Search and Rescue

Eligibility: Dogs certified to assist in wilderness and urban tracking, natural disasters, mass casualty events and locating missing people.

Therapy

Eligibility: Certified therapy dogs working in hospitals, schools, disaster sites, war zones, and wherever else the affection of a good dog can provide comfort.

Service

Eligibility: Service dogs who enrich the lives of physically or mentally disabled owners, including, but not limited to, guide dogs for the blind, seizure-alert dogs, hearing dogs, balance dogs.

\*\*(Note: Nominees doing therapy work without certification are considered in the Exemplary Companion category.)

Honorees will receive an engraved sterling-silver medallion and an all-expenses-paid trip for dog and owner to Orlando, Florida, to be honored at the AKC National Championship presented by Royal Canin in December. A donation of \$1,000 will also be made in each recipient's name to the pet-related charity of their choice.

Anyone, including the dog's owner or handler, may submit a <u>nomination form</u>.

Submissions for the AKC Humane Fund Awards for Canine Excellence for 2020 must include:

- A digital photograph of the dog. Files must be larger than 1MB in size and a minimum of 300 dpi. The photo should feature solely the nominated dog.
- A 500-word-or-less description of how the dog has demonstrated excellence.
- Dog's call name, breed, age and sex.
- Owner's/Nominator's name(s), address and phone number. E-mail address if available.

Nominations will be accepted through July 31, 2020 and should be submitted <a href="here">here</a>, with a photo sent tocommunications@akc.org.

## **AKC Government Relations 2019 Highlights**

Currently, Congress, five states, and the District of Columbia are in legislative session. 17 States are accepting pre-filed bills for 2020. AKC Government Relations is currently tracking more than 2,350 bills on the federal, state, and local levels.

AKC GR has been active in all 50 states. AKC GR has issued 152 legislative alerts in 2019, and provided comments and/or oral and written testimony on more than 100 pieces of canine legislation. The addition of new field staff in the last two years has enabled AKC GR to significantly increase in the amount of in-person contact and in-person testimony we provide at the state and local levels. One-on-one engagement is resulting in significant new levels of influence, recognition, and successes in key policy areas such as protecting the rights of breeders and owners, preserving AKC events, and AKC representation on officially-recognized expert policy panels.

As is typical for this time of year, we are currently seeing more action at local (county, city municipal) levels. A "hot issues" update of state and local issues is provided, and I would be happy to provide more updates.

Many bills fall into multiple categories, however the top issues we are seeing at the state and local level right now (in order) are:

- Cruelty
- Working Dogs
- Other (including breeder licensing)
- Veterinary
- Animal Control
- Retail Sales

AKC GR communicates to fog owners, club members, lawmakers and the public via geo-targeted legislative alerts, online alerts, facebook/twitter and other social media, The *Taking* 

Command (monthly advocacy) and In Session (policy) newsletters, blogs, newspaper Op Eds, as well as through direct one-on-one contact and outreach with club-based legislative liaisons.

AKC GT has also been having regular calls with our counterparts in Canada (CKC) who are dealing with similar and related legislative threats. In sharing information, we can each learn more about and be prepared to address animal rights politics as an international agenda.

Every member of the AKC GR team (11 total) participates in legislative analysis and comment. We are broken down geographically into 5 general regions, 4 of which have staff in the field (West Coast, New England, Southeast and "Mid-Atlantic Plus" regions) to work with dog owners and policymakers on issues that impact dog ownership and our sport. GR field staff, as well as NC staff are available to speak to clubs, provide testimony, advocacy training, assist with outreach, and help alert constituents and assist in taking action on issues of concern in those regions. GR regional team members are also registered as lobbyists in key states in their regions.

In 2019, AKC GR hired two new staff: Mikki McGinnis (Admin Assistant and Service Dog Project Manager) and Charles Hall ("Mid-Atlantic Plus" Legislative Analyst/Community Outreach Coordinator. Mr. Hall is scheduled to start at the beginning of Jan. 2020.)

Our federal lobbyist of more than 10 years (Mike Williams) is working on issues related to pet imports, Breeder Licensing, the Detection Dog Shortage, and other issues that impact us at the federal level. Federal issues are crucial because of their capacity to quickly impact the largest number of dog owners across the country.

AKC GR has registered lobbyists (both staff and contract) in key states. The states where we register lobbyists varies from year to year depending on activity level, availability and specific issues. In 2019, we currently have lobbyists registered in AL, CA, CT, KY, MD, NJ, NC, NH, OH, PA, RI, VA.

#### Federal Issues: We are focusing on several key areas:

Imports of Unhealthy Dogs. More than 1 million dogs are being imported into the US on an annual basis. We believe the vast majority of these dogs are intended for transfer or resale in retail rescue or other retail markets. A large number of these dogs are entering with minimal health checks, and in many cases invalid health certificates. Combined with the "adopt don't shop" mantra, many of these animals not only undermine demand for well-bred purebred dogs, they pose an imminent and significant health threat to humans, pets and livestock. AKC is working together with NAIA on federal legislation to require that dogs entering the US for transfer ( adoption, resale, etc.) have valid veterinary certificates from a competent veterinary authority that can be checked when they enter the US. Importers that attempt to import dogs that do not meet health standards would be required to return them to the country of origin!

<u>Federal Breeder Licensing Regulations and Legislation.</u> HR 3164, the House-passed FY 2020 Agricultural Appropriations bill would require USDA APHIS to include personally identifiable information such as residential addresses and "animal inventories" in an online, publicly-searchable database of USDA licensed dog breeders. AKC agrees with USDA that



adding personal information is not necessary for assuring animal welfare. Moreover, we believe that unnecessary publication of such information creates a virtual "shopping list" for animal rights activists and pet thieves who wish to target individual breeders. Such measures not only hurt responsible breeders but are likely to dampen efforts to improve licensing compliance and the welfare oversight of animals in licensed facilities.

<u>Service Dogs.</u> AKC GR is working with US Department of Transportation and providing comment on potential rules changes regarding the federal air carrier access act, and other federal laws impacting assistance animals.

AKC GR is also working with colleagues at the American Service Dog Access Coalition, and industry colleagues including: airlines, the airline industry associations, service dog groups, and governments to continue to develop all aspects of a new authoritative, voluntary and verifiable credential to streamline access for service dog teams that meet specific behavioral, ask-based and health standards. AKC presented at the Association of Service Dog Providers for Military Veterans and obtained updated buy-in on the program from the association's members, who will help beta test the new program. Expanded evaluator requirements have been developed, and database technology is in development.

**Airlines issues.** While cargo issues are not be strictly legislative or regulatory issues, AKC GR is working with airline industry leaders to address issues related to airline bans on dogs in cargo based on size and breed.

**Detection Dog Task Force**. In September, GR took on staff oversight and administration of this program. GR actively engages with government and law enforcement for updated information on detection dog requirements to assist with shortage issues. The Patriotic Puppy program, and contractor Scott Thomas works directly with breeders/owners and trainers to produce dogs that are suitable for purchase by law enforcement, military and private security. In December, the first participant from the AKC patriotic puppy program was acquired by law enforcement.

**Anti-Breeder Harassment Task Force.** At the April Board meeting, AKC GR proposed the establishment of an informal taskforce/resources working group on anti-breeder harassment or retaliation with input from multiple AKC Departments and outside experts. The purpose of the taskforce is to centralize reports of this nature to AKC so recommendations for available action can be reviewed, compiled and disseminated as a resource for responsible breeders and dog experts. Taskforce members include AKC staff; input may also be obtained where appropriate from animal control, law enforcement, and legal experts. The GR team is continuing the development of resources, operation, communications and database tools for the initiative.

Law School Outreach/Student Writing Contest. The third annual AKC Law School Companion Animal Writing Contest concluded in December. Students at ABA-accredited law schools are invited to submit articles on a choice of topics related to animal rights and other key issues impacting pet ownership. The contest is designed to raise awareness of non-animal-rights aspects of animal law, and to broaden conversation among future leaders in this area.

Canines at the Capitol Events: AKC GR staff conducted canines at the capitol events in Washington DC, California, Maryland, Maine and North Carolina. The popular events provide legislators and staff educational information about AKC, information on key legislative policy positions, and the opportunity to meet dogs from each of the seven groups. The events are covered by local media and create new goodwill at the capitol and state legislatures, as well as new opportunities to discuss canine legislation issues with lawmakers.

National and Regional Legislator Conferences: GR staff participated in and prepared policy exhibits for numerous professional conferences for legislators, including the National Conference of State Legislators (NCSL), American Legislative Exchange Council (ALEC), and the National Association of Counties (NACo), The Congressional Sportsmens Caucus, The National Assembly of (state) Sportsmens Caucuses (NASC), The National League of Cities, and individual state associations of municipalities conferences. Extensive contacts with lawmakers and decisionmakers were made at these events. In a number of cases, invitations to advise legislators on future and existing legislation and positive changes to pending legislation were a direct result of outreach made at the conferences.

**New Internal Legislative Tracking Database Development Completed:** Development of a new internal legislative tracking and contact management database system (Fiscal Note) was completed and is currently being implemented, along with training for all staff. This program is designed to improve staff efficiency, effectiveness and measurable impacts. Full implementation and training are anticipated before the end of the year.

**National Conference, mini conferences and seminars:** A two-day national conference was held in Washington DC in conjunction with lobby-day events and a Capitol Hill reception and mini-meet the breeds in honor of purpose-bred dogs. Approximately 400 congressional staff and members attended the event. Multiple smaller conferences, events and live seminars were conducted in more than a dozen states.

## Top 10 Questions to Ask When Getting a Dog from a Shelter



Congratulations on making the decision to welcome a new furry friend into your home. Just as it's important to ask breeders questions about their practices before purchasing a puppy, it's equally important to do a little digging before rescuing a dog from a shelter. Here are some pre-adoption questions to ask to make sure the dog your select is the best fit for you and your family.

- 1. Why is this dog in a shelter? (a. owner surrender, b. stray, c. rescue)
  - a. Why did the owner surrender the dog?
  - b. Where was this stray dog found and in what condition?
  - c. Is this animal here as a result of an animal cruelty charge against its previous owner?
- 2. What was the condition of the dog when he was brought to the shelter?
- 3. Has this dog been adopted out before?
- 4. What veterinary care has the dog received since arriving at the shelter and can you provide copies of those veterinary records? Is this dog housebroken?

- 5. Does this dog get along well with children or other pets and how does he act around strangers?
- 6. Does this dog have suitable good manners that I could take away his food bowl while eating or remove his toy while playing?
- 7. Can this dog walk calmly on a leash in public or does he need further training?
- 8. Does this dog require any special medical care, ongoing treatment or dietary restrictions?
- 9. Will the shelter take this dog back if it doesn't work out with my family?
- 10. Tip: Is your shelter dog a mixed-breed? Check out the <u>AKC Canine Partners</u> Program to learn about events and opportunities for mixed-breed dogs.
