Entries will be drawn: 6:00pm Thursday, February 18, 2021 at 102 Carpenter Brook Dr, Cary, NC, and the public is invited. The drawing will be at random among all entries received except that preference will be given to untitled dogs in the TD test and non TDX dogs in the TDX test. When the advertised limit has been drawn, all remaining entries shall be assigned a position on an alternate list corresponding to the order in which they were drawn, subject to the same preferences set forth above.

Entrants will be contacted by telephone or email between 6:30 – 8:00 PM EST Thursday, February 18, 2021. All those submitting entries (or their designated agent) are requested to be available for this notification. A judging program will be sent to entrants and alternates following the drawing for entries.

If an accepted entry is absent on the day of the test, it shall be the responsibility of the Test Secretary to determine whether any alternates are present. If so, spaces will be filled by such alternates, in the order in which they were drawn, giving preference to untitled dogs.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

Errors on Entry Blanks: **Owners are responsible for errors in making out forms, whoever may make such errors, and no entry fee will be refunded in the event of such errors or cancellations of entries after the published closing date.**

COVID Information

DKC will follow AKC's COVID-19 Suggested Best Practices for Tracking

All attendees must sign the DKC Covid Affirmation and Waiver for the February 28, 2021 Tracking Test, even if they are not entered in the test. The waiver is included at the end of this premium and should be completed and brought with you to the trial site.

If, within 14 days leading up to the test, you have experienced symptoms of or tested positive for Covid-19, or have been in contact with someone who has experienced symptoms of or tested positive for Covid-19, please notify the trial secretary to withdraw your entry (your entry fees will be refunded).

Please wash your hands and/or use hand sanitizer frequently. Masks are required on DKC property and inside the building, as well as the fields where the test is being held, unless you are inside your vehicle or preparing to track and tracking your dog.

There will be no Pot Luck luncheon after the conclusion of the test. We will provide bottled water and a light, individually wrapped snack.

Telegraph, Telephone and unsigned entries cannot be accepted.

The entry fee will be refunded for an accepted entry that withdraws after the closing date **only** if there is an alternate to take his or her place. The entry fee will also be refunded for an alternate that does not participate. Entry fees will be refunded within 7 days following the test.

The Durham Kennel Club reserves the right to cancel the event if extreme weather conditions arise.

The event show hours are 7:00AM to 2PM on February 28, 2021. TD Entrants will meet at the Durham Kennel Club Building at 7:15 AM and proceed to the fields as a group (a 20 - 30-minute drive). The Building will open at 7:00. The drawing for the tracks will be held at the fields, with the first TD track running at 8 AM or as soon as it is available. The Building will reopen at 9:00. TDX Entrants will meet at the Durham Kennel Club Building at 9:00 AM and proceed to the fields as a group (a 20 - 30-minute drive). The drawing for the tracks will be held at the fields, with the first TDX track running at 10:00AM or as soon as it is available. Any change in this schedule will be communicated to the entrants either by email or phone call after the tracks have been plotted on Saturday, February 27, 2021.

I (we) acknowledge that the "Rules Applying to Dog Shows/Registration and Discipline" and, if this entry is for an obedience trial and/or agility trial, the "Obedience Regulations", and/or the "Agility Trial Regulations", have been made available to me (us), and that I am (we are) familiar with their contents. I (we) waive any and all claims, causes of action, I (we) might otherwise have against the AKC and any AKC approved judge, judging at this show, under the "AKC Rules, Regulations and Guidelines". I (we) agree that the club holding this show, obedience trial and/or agility trial has the right to refuse this entry for cause which the club shall deem to be sufficient. Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.). Dachshunds (longhaired, smooth, wirehaired), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard), Collies (rough, smooth).
- The following categories or dogs may be entered and shown in Best of Breed competition; Dogs that are Champions of Record and dogs which according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Dog Show Class) Consult the classification in the show's premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a show closed.
