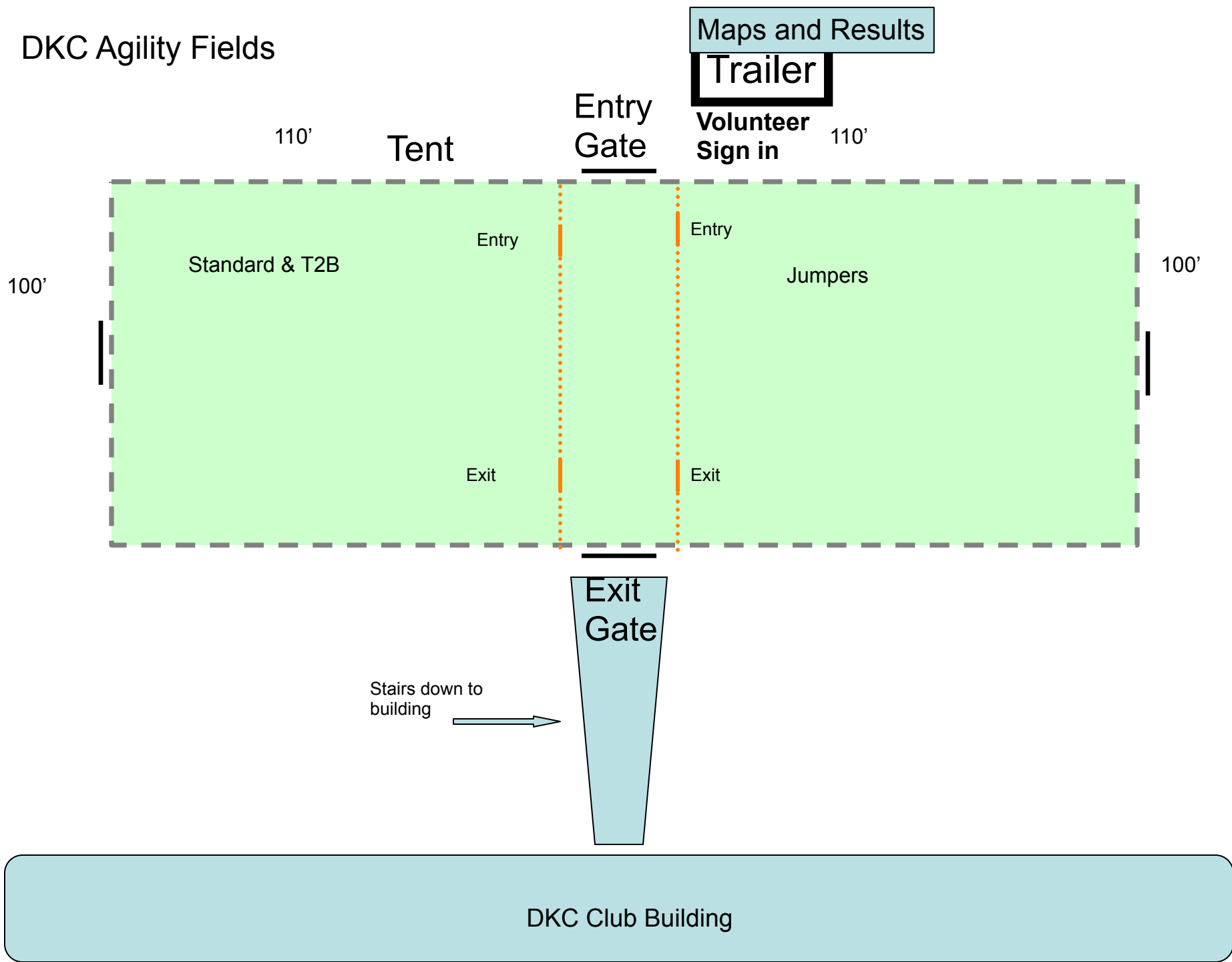


# DKC Agility Fields



**Durham Kennel Club Agility Trial**  
**Covid Protocols**

**General**

1. Masks should be worn all times that you are not social distancing and not in your “group”. Shields are fine, but a mask must be worn in addition to the shield.
2. You do not need to wear a mask when you run your dog. Please wear your mask into the ring and put it back on before you leave the ring.
3. Please wear your mask for warmup.
4. Please wear your mask in the building, bathrooms, and port-a-potties.
5. Hand sanitizer will be available in miscellaneous places.
6. If you did not submit a Covid waiver with your entry, you must bring a signed waiver to the trial. A basket for the waivers will be placed in the lobby of the building. Please put your waiver in it when you arrive at the trial. The waiver is available at [www.earlyagility.com](http://www.earlyagility.com).
7. If you do not have a mask, there will be some on the table outside the ring at the entry gate to the field.
8. The entry gate for the rings is on the side of the “hill”. The exit gate is on the building side. Please use them as directed. (See attached map)
9. Do not hang out in the area between the 2 rings. Go into that area a few dogs before your run and leave right after you reward your dog.
10. Leash runner must wear a mask. You may carry your leash in your pocket or around your waist. For others a bucket or leash grabber will be used to take your leash to the exit.
11. Ring Crew do not have to wear a mask unless they are going to be within 6 ft of competitors.
12. Scribes, timers, and score runners must wear masks.
13. There will be no workers’ snacks, but there will be water.
14. There will be no food available onsite. Hopefully, by Fall we will be able to have food again!

**Building Use**

1. There will be no crating in the building except for the trial committee.
2. The Trial Secretary will be in the building.

- 3. The ribbons will be in the building spread out on a table. They will be self-serve. Results will be posted on the trailer near the entry gate to the field (see map). There will be no stickers, so you will need to write down or take a picture of the results. The trial secretary will also post results on her website as well as email all exhibitors their results at the end of the trial.**
- 4. You may use the bathrooms in the building, as well as the port-a-potty.**

### **Trial Specific Information**

- 1. We will be using the Agility Gate App. There will be a paper check-in too. Please use the app to check-in or scratch if you possibly can. This greatly relieves congestion around the gate steward. We will be using a microphone to announce the lineup as we go, but you can follow that on Agility Gate, too.**
- 2. Please volunteer! We will have an online sign-up sheet. Beth White is our volunteer coordinator.**

## **Durham Kennel Club COVID-19 Waiver Agility Trial April 23-25, 2021**

- A face covering that covers the nose and mouth is REQUIRED to be worn in the DKC building at all times regardless of how many people are in the building when you are here.

- A face covering that covers the nose and mouth is REQUIRED to be worn during the agility walk throughs regardless of the number of people in the class.
